BILL NO. 949ORDINANCE NO. 774

AN ORDINANCE AMENDING THE WASHOE COUNTY CODE BY CLARIFYING PROVISIONS PERTAINING TO DEPUTY DISTRICT ATTORNEYS AND DEPUTY PUBLIC DEFENDERS.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

SECTION 1. Section 5.094 of the Washoe County Code is hereby amended to read as follows:

5.094 Legal professional employee: Rights, privileges and benefits; inapplicability of certain code provisions.

1. A legal professional employee is entitled to the rights, privileges and benefits of an employee in the classified service pertaining to holidays, career incentive accrual and pay, vacation leave accrual and pay, sick leave accrual and pay, personal leave accrual and pay, leaves of absence, travel expenses and any other benefits deemed appropriate by the board of county commissioners.

2. Except as provided in subsection 1, the provisions of this chapter do not apply to legal professional employees. The inapplicable provisions include, but are not limited to, those relating to appointment, promotion, demotion, salary adjustment, transfer, rehire, discipline and discharge.
