AN ORDINANCE DISSOLVING THE SILVER KNOLLS COMMUNITY PARK SPECIAL IMPROVEMENT DISTRICT, THE THOMAS CREEK COMMUNITY PARK SPECIAL IMPROVEMENT DISTRICT, AND THE MOGUL NEIGHBORHOOD PARK LOCAL IMPROVEMENT DISTRICT BY REPEALING THE ORDINANCES THAT CREATED THEM.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

SECTION 1.

Findings.

1. Pursuant to NRS Chapter 271, this Board created the Silver Knolls Community Park Special Improvement District by Ordinance 653 effective June 24, 1985.

2. Pursuant to NRS Chapter 271, this Board created the Thomas Creek Community Special Improvement District by Ordinance 687 effective April 28, 1986.

3. Pursuant to NRS Chapter 271, this Board created the Mogul Neighborhood Park Local Improvement District by Ordinance 793 effective April 30, 1990.

4. The purpose of creation of these Districts was to provide a method of providing funds for maintenance of the parks located within the Districts. Since their creation, new funding sources have become available, and the Districts are no longer required.

SECTION 2.

Prior Ordinances Repealed.

1. Ordinance 653 adopted on June 11, 1985 is hereby repealed.

2. Ordinance 687 adopted on April 15, 1986 is hereby

repealed.

3. Ordinance 793 adopted on March 20, 1990 is hereby repealed.
