ORDINANCE NO. 807

AN ORDINANCE AMENDING CHAPTER 110 OF THE WASHOE COUNTY CODE BY ADDING THERETO PROVISIONS CREATING THE DEPARTMENT OF DEVELOPMENT REVIEW.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

SECTION 1. Chapter 110 of the Washoe County Code is hereby amended by adding thereto the provisions set forth as sections 2 through 6, inclusive, of this ordinance.

SECTION 2.

110.0205 Department of development review: Creation.

1. There is hereby created the Washoe County department

of development review.

2. The department shall be responsible for the de elopment and administration of development review programs for the county in accordance with relevant local, state and federal ordinances, laws and regulations, as well as such other functions as may be assigned by the board of county commissioners.

SECTION 3.

110.0206 <u>Director of department of development</u> review: Position created; appointments; term; staff.

1. The position of director of the department of development review is hereby created. The director shall be appointed by the board of county commissioners upon recommendation of the county manager and shall serve at the pleasure of the board of county commissioners.

2. The director shall appoint, pursuant to any applicable provisions of law regulating county personnel, such technical, clerical and operating staff as the execution of the duties of the director and operation of the department may require.

SECTION 4.

110.0207 <u>Director of department of development</u>
review: <u>Powers and duties</u>. As the executive head of the department, the director shall direct and supervise all administrative, technical and operational activities of

the department. In addition to such activities as may be required in the daily administration of the department, the board of county commissioners may make additional assignments as deemed necessary.

SECTION 5.

110.0208 <u>Compensation of director, employees of</u> department of development review; payment of salaries.

1. Except as provided in subsection 2, the salaries and other fringe benefits of the director and employees of the department of development review shall be established in accordance with the provisions of the Merit Personnel Ordinance or any other applicable law regulating the employment of county personnel.

2. The salary for the position of director shall be

established by the board of county commissioners.

SECTION 6.

110.0209 Divisions of department of development review. The department shall consist of such divisions, created upon the recommendation of the director of the department of development review, as are deemed necessary to the efficient performance of the department.
