ORDINANCE NO. 835

AN ORDINANCE ESTABLISHING A COMPENSATION SCHEDULE FOR MEMBERS OF THE LOCAL DISTRICT MANAGING BOARD FOR SOUTH TRUCKEE MEADOWS GENERAL IMPROVEMENT DISTRICT.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

Section 1 of Ordinance No. 537 is hereby amended to read as follows:

SECTION 1. Managing Board; creation; composition and compensation.

- 1. The Local District Managing Board of the South Truckee Meadows General Improvement District is hereby created.
- 2. The Managing Board consists of five members who are qualified electors of the District. The initial members shall be appointed by the Board of County Commissioners as follows:
 - A. Two members shall serve until the first Monday in January, 1983.
 - B. Three members shall serve until the first Monday in January, 1985.
- 3. After their initial terms, members shall serve a term of office of 4 years, terminating on the first Monday in January next following the general election at which their successor in office is elected.
- 4. The Managing Board shall choose a chairman, vice-chairman and secretary from among its members. Officers of the Board shall serve at its pleasure. The secretary, among other duties, shall keep written minutes of each of the Managing Board's meetings in compliance with Chapter 24l of the Nevada Revised Statutes (Nevada's "Open Meeting Law").
- 5. Members of the Managing Board shall receive as compensation for their services fifty dollars (\$50.00) for each regular meeting attended by the board member, not to exceed three thousand dollars (\$3,000.00) per year for all members.

The payment may not be made for a special meeting or for a regular meeting at which the member was absent.

The payment may be made only to members elected at the general election in 1992 and at any general election held thereafter.
