SUMMARY: Amends Washoe County Code by establishing an administrative fee for intermittent sentences pursuant to NRS 211.350.

AN ORDINANCE AMENDING CHAPTER 125 OF THE WASHOE COUNTY CODE TO ESTABLISH AN ADMINISTRATIVE FEE FOR PERSONS SERVING INTERMITTENT SENTENCES AS PROVIDED IN NRS 211.350; AND PROVIDING OTHER MATTERS PROPERLY RELATING THERETO.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

SECTION 1. Chapter 125 of the Washoe County Code is hereby amended by adding thereto the provisions set forth as Section 2 of this ordinance.

## SECTION 2.

125.090 Administrative fee for inmates serving intermittent sentence.

- 1. When a court of competent jurisdiction has granted an application to an inmate in the county jail to serve out the inmate's sentence on an intermittent basis in accordance with NRS 211.350(2), the inmate shall pay to the county \$25.00 per day for each day so served.
- 2. An inmate serving an intermittent sentence in accordance with section 1 hereof, shall pay the \$25 a day fee to the county in accordance with the court's direction.
- 3. An inmate serving an intermittent sentence as provided for herein, shall pay toward the \$25 per day fee according to his ability to pay.

4. The finance division shall establish criteria to

determine an inmate's ability to pay.

5. The fees collected pursuant to the provisions of this section and to NRS 211.350 shall be deposited in the general fund.
