AN ORDINANCE AMENDING THE WASHOE COUNTY CODE BY ELIMINATING THE REPRODUCTION DEPARTMENT AND TRANSFERRING ITS FUNCTIONS TO THE GENERAL SERVICES DEPARTMENT; AND PROVIDING OTHER MATTERS PROPERLY RELATING THERETO.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

SECTION 1. Section 80.410 of the Washoe County Code is hereby amended by to read as follows:

80.410 Creation of general services department.

1. There is hereby created, pursuant to the provisions of NRS 244.195, the Washoe County general services department.

2. The department shall:

(a) Be responsible for the functions and operation of all county buildings and grounds facilities, including maintenance, gardening, janitorial services, minor construction and repairs, except as otherwise directed by the board of county commissioners.

(b) Be responsible for providing reproduction services to the county, including a print shop; providing mail room and mail delivery services; providing records management,

including microfilming services.

(c) Perform such other functions as may be assigned from time to time by the board of county commissioners.

SECTION 2. Section 5.459 of the Washoe County Code is hereby repealed.
