ordinance no. 880

AN ORDINANCE AMENDING THE WASHOE COUNTY CODE BY INCREASING THE FEES CHARGED BY THE RECORDER FOR RECORDING MAPS OF DIVISIONS INTO LARGE PARCELS.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

SECTION 1. Section 115.450 of the Washoe County Code is hereby amended to read as follows:

115.450 Maps of divisions into large parcels: Filing fee; recording fee.

- 1. Any person required by law to file with the planning commission a map of division into large parcels shall upon filing with the planning commission pay a filing fee of \$200.
- 2. Any person required by law to file with the county recorder a map of division into large parcels shall upon filing with the county recorder pay for the recording of the map the amount of \$35 for the first page of the map plus a fee of \$15 for each additional page thereof.
