SUMMARY: Amends Washoe County Code by increasing fees charged by recorder to record maps of divisions into large parcels.

> BILL NO. 1069 ORDINANCE NO. 894

AN ORDINANCE AMENDING THE WASHOE COUNTY CODE BY INCREASING THE FEES CHARGED BY THE RECORDER FOR RECORDING MAPS OF DIVISIONS INTO LARGE PARCELS.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

SECTION 1. Purpose, validity of previous actions.

1. The purpose of this ordinance is to move the provisions of the Washoe County Code relating to the fees charged by the recorder for recording maps of divisions of large parcels from the provisions dealing with subdivision of land to chapter 20

dealing with revenue and taxation.

- 2. Notwithstanding any defects or irregularities, all acts and proceedings taken by the board of county commissioners, and the recorder, or purportedly had or taken under law or under color of law by them, in fixing, imposing and collecting the fees provided for in Washoe County Ordinance No. 880 and for recording and filing a map of division into large parcels, prior to the adoption of the Washoe County Code by enactment of county ordinances, including Washoe County Ordinance No. 894, and all actions and proceedings are hereby validated, ratified, approved and confirmed.
- 3. In the event any provision of this section 1 is deemed to be unlawful by a court of competent jurisdiction, the invalidity of such section shall not affect the remaining sections.

SECTION 2. Chapter 20 of the Washoe County Code is hereby amended by adding thereto a new section which shall read as follows:

20.725 Recording fees for maps of divisions into

large parcels.

Any person required by law to file with the county recorder a map of division into large parcels shall upon filing with the county recorder pay for the recording of the map the amount of \$35 for the first page of the map plus a fee of \$15 for each additional page thereof.
