SUMMARY: An ordinance amending the Washoe County Code by imposing an additional 5 cents per gallon motor vehicle fuel tax and providing for the effective dates thereof.

Bill No. <u>1072</u> Ordinance No. <u>847</u>

AN ORDINANCE AMENDING THE WASHOE COUNTY CODE BY IMPOSING AN ADDITIONAL 5 CENTS PER GALLON MOTOR VEHICLE FUEL TAX AND PROVIDING FOR THE EFFECTIVE DATES THEREOF.

THE BOARD OF COUNTY COMMISSIONERS OF WASHOE COUNTY DO ORDAIN:

<u>SECTION 1.</u> Chapter 20 of the Washoe County Code is hereby amended by adding thereto the provisions set forth in sections 2 to 4, inclusive, of this ordinance.

SECTION 2.

20.368 <u>Imposition and rate of additional tax.</u> In addition to the excise tax imposed by section 20.367, every dealer shall pay an additional excise tax of 5 cents per gallon on all motor vehicle fuel sold, distributed or used, in the same manner, within the time prescribed, and subject to the same procedures applicable to the tax imposed by section 20.367.

SECTION 3.

20.3681 <u>Effective date of additional tax.</u> The additional motor vehicle fuel tax imposed pursuant to section 20.368, shall be imposed and become effective on the first day of the second calendar month next following the enactment of this ordinance.

SECTION 4.

20.3682 Amendment of contract with department of taxation. Unless the board of county commissioners, with the written concurrence of the commission, determines that an amendment is not necessary or desirable, the county shall amend the contract made pursuant to section 20.357 to provide for functions incident to the administration and operation of the additional 5 cents per gallon motor vehicle fuel tax.

SECTION 5. Ending date of additional tax. Unless a new ordinance is enacted by the board, the additional motor vehicle fuel tax imposed pursuant to section 1 of this ordinance shall remain in full force and effect through June 30, 1994.
