

ORDINANCE NO. 940

AN ORDINANCE AMENDING THE WASHOE COUNTY CODE BY EXPANDING THE GREATER TRUCKEE MEADOWS AND ENVIRONS CONGESTED AREA TO PROHIBIT THE DISCHARGE OF FIREARMS AND ADDING HUNGRY VALLEY AS A CONGESTED AREA TO PROHIBIT DISCHARGE OF FIREARMS.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

SECTION 1. Chapter 50 of the Washoe County Code is hereby amended by adding thereto the provisions set forth as section 2 of this ordinance.

SECTION 2.

50.118 Hungry Valley: Congested area. The Hungry Valley area is determined to be a congested area and is specifically described as: All of sections 4, 9 and 16 in T. 21 N., R. 20 E., M.D.B.&M.

SECTION 3. Section 50.096 of the Washoe County Code is hereby amended to read as follows:




