ORDINANCE NO. 993

AN ORDINANCE AMENDING CHAPTER 20 OF THE WASHOE COUNTY CODE BY ADDING THERETO PROVISIONS AUTHORIZING JUSTICE COURTS TO IMPOSE A \$10 ADMINISTRATIVE ASSESSMENT.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

<u>SECTION 1.</u> Chapter 20 of the Washoe County Code is hereby amended by adding thereto the provisions set forth as sections 2 and 3 of this ordinance.

SECTION 2.

- 20.750 <u>Justice courts: Authorization for administrative assessment.</u>
- 1. Pursuant to Chapter 75 of the Statutes of Nevada, 1997, p. 140, the justice courts are hereby authorized to impose a \$10 administrative assessment for the provision of court facilities.
- 2. The administrative assessment shall be imposed and collected in accordance with the provisions of Chapter 75 of the Statutes of Nevada, 1997, p. 140.

SECTION 3.

This ordinance shall be effective from and after October 14, 1997.
