## ORDINANCE NO. 1013

AN ORDINANCE ABOLISHING ELECTED POSITIONS OF CONSTABLE WITHIN THE COUNTY OF WASHOE; AMENDING WASHOE COUNTY CODE SECTIONS RELATING TO CONSTABLE; AND OTHER MATTERS RELATING THERETO.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:


<u>SECTION 1</u>. The Washoe County Code is hereby amended to read as set forth in Sections 2 through 12 of this ordinance.

<u>SECTION 2</u>. Chapter 5 of the Washoe County Code is hereby amended by adding a new section 5.465 to read as follows:

5.465 Abolishment of office of constable. Pursuant to the au-

thority granted in NRS 258.010:

- 1. The board of county commissioners, having made a finding that the office of constable is not necessary in the townships of Gerlach, Reno, Sparks, Verdi and Wadsworth, hereby abolishes said office in those townships to be effective upon the completion of the terms of office of the current constable officeholders.
- 2. The board of county commissioners, having made a finding that the office of constable is not necessary in the township of Incline if an alternate means is developed to provide the unique, non-constable-related, services currently provided by the Incline constable, hereby abolishes said office in the Incline township to be effective upon the completion of the term of office of the constable in office on January 4, 1999.
- <u>SECTION 3</u>. Chapter 5, Section 5.093, of the Washoe County Code is hereby amended to read as follows:
- 5.093 <u>Unclassified service: Composition, salaries set by county commissioners.</u>
- 1. The unclassified service of Washoe County shall be comprised of positions held by county officers or employees, as follows:
- (a) Persons chosen by election or appointment to fill an elective office.
- (b) Members of appointed boards and commissions, and appointed heads of departments.



(d) At the discretion of the elective officer or head of each department, a number of employees in each department, excluding the elective officer or department head, as designated by the elective officer or department head, which shall not exceed 3 percent of the permanently established positions as authorized by the board of county commissioners. If 3 percent of such positions is less than one employee, the elective officer or department head is entitled to at least one such unclassified employee.

(e) Physicians employed as full-time employees.

(f) Persons holding temporary part-time or temporary full-time appointments the duration of which does not exceed 6 months.

(g) Part-time professional personnel who are paid for any form

of medical, nursing or other professional service.

(h) Foreign exchange students working in county departments pursuant to a student foreign exchange work program agreement between the University of Nevada and other countries.

(i) Such other officers and employees as are authorized by law

to be employed in the unclassified service.

2. An elective officer or head of each department who elects to exercise his discretion as permitted by paragraph (c) of subsection 1 shall immediately report to the personnel department the positions designated by him to be in the unclassified service. An established classified position may not be declassified, nor an established unclassified position classified, while that position is occupied.

3. Salaries of all persons in the unclassified service, whose salaries are set by the board of county commissioners and excluding county elective officers whose salaries are fixed by statute,

shall be fixed by the board of county commissioners.


4. No person appointed to the unclassified service shall be entitled to the rights, privileges or provisions of the classified service relative to appointment, promotion, demotion, transfer or rehire. An unclassified employee shall serve at the pleasure of the appointing authority.

<u>SECTION 4</u>. Chapter 20, Section 20.243, of the Washoe County Code is hereby amended to read as follows:


20.243 Warrant for collection of tax: Issuance; effect; levy and sale.

1. At any time within 3 years after any person is delinquent in the payment of any amount herein required to be paid, or within 3 years after the last recording of an abstract under section 20.231, or of a certificate under section 20.237, the department or its authorized representative may issue a warrant for the enforcement of any liens and for the collection of any amount required to be paid to the county under the Relief Tax Ordinance.

2. The warrant shall be directed to any sheriff and shall have

- <u>SECTION 5</u>. Chapter 20, Section 20.245, of the Washoe County Code is hereby amended to read as follows:

The department may pay or advance to the sheriff the same fees, commissions and expenses for his services as are provided by law for similar services pursuant to a writ of execution. The department, and not the court, shall approve the fees for publication in a newspaper.
- <u>SECTION 6</u>. Chapter 20, Section 20.247, of the Washoe County Code is hereby amended to read as follows:
- 20.247 <u>Liability for fees of sheriff.</u> The fees, commissions and expenses are the obligation of the person required to pay any amount under the Relief Tax Ordinance and may be collected from him by virtue of the warrant or in any other manner provided in the Relief Tax Ordinance for the collection of the tax.
- <u>SECTION 7</u>. Chapter 20, Section 20.619, of the Washoe County Code is hereby amended to read as follows:
- 20.619 Warrant for collection of tax: Issuance; effect; levy and sale.
- 1. At any time within 3 years after any person is delinquent in the payment of any amount herein required to be paid, or within 3 years after the last recording of an abstract under section 20.613, or of a certificate under section 20.616, the department or its authorized representative may issue a warrant for the enforcement of any liens and for the collection of any amount required to be paid to Washoe County under sections 20.502 to 20.665, inclusive.
- 2. The warrant shall be directed to any sheriff and shall have the same effect as a writ of execution.
- 3. The warrant shall be levied and sale made pursuant to it in the same manner and with the same effect as a levy of and a sale pursuant to a writ of execution.
- <u>SECTION 8</u>. Chapter 20, Section 20.620, of the Washoe County Code is hereby amended to read as follows:
- 20.620 Fees for services of sheriff; approval of newspaper publication fees. The department may pay or advance to the



- <u>SECTION 9</u>. Chapter 20, Section 20.621, of the Washoe County Code is hereby amended to read as follows:
- 20.621 <u>Liability for fees of sheriff.</u> The fees, commissions and expenses are the obligation of the person required to pay any amount under sections 20.502 to 20.665, and may be collected from him by virtue of the warrant or in any other manner provided in sections 20.502 to 20.665, inclusive, for the collection of the tax.
- <u>SECTION 10</u>. Chapter 21, Section 21.1170, of the Washoe County Code is hereby amended to read as follows:
  - 21.1170 Issuance; effect; levy and sale.
- 1. At any time within 3 years after any person is delinquent in the payment of any amount herein required to be paid, or within 3 years after the last recording of an abstract under section 21.1120, or of a certificate under section 21.1140, the department or its authorized representative may issue a warrant for the enforcement of any liens and for the collection of any amount required to be paid to a county under this chapter.
- 2. The warrant shall be directed to any sheriff and shall have the same effect as a writ of execution.
- 3. The warrant shall be levied and sale made pursuant to it in the same manner and with the same effect as a levy of and a sale pursuant to a writ of execution.
- <u>SECTION 11</u>. Chapter 21, Section 21.1180, of the Washoe County Code is hereby amended to read as follows:
- 21.1180 Fees for services of sheriff; approval of fees for publication in newspaper. The department may pay or advance to the sheriff the same fees, commissions and expenses for his services as are provided by law for similar services pursuant to a writ of execution. The department, and not the court, shall approve the fees for publication in a newspaper.
- SECTION 12. Chapter 21, Section 21.1190, of the Washoe County Code is hereby amended to read as follows:
- 21.1190 <u>Liability for fees of sheriff; collection.</u> The fees, commissions and expenses are the obligation of the person required to pay any amount under this chapter, and may be collected



from him by virtue of the warrant or in any other manner provided in this chapter for the collection of the tax.
