

ORDINANCE NO. 1095

AN ORDINANCE ADOPTING SUPPLEMENT NUMBER 7 TO THE WASHOE COUNTY CODE AND ALL CLERICAL AND TECHNICAL CORRECTIONS MADE THEREIN.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

SECTION 1. Supplement No. 7 to the Washoe County Code, together with all clerical and technical revisions to the general ordinances contained therein, is hereby ratified and adopted. Clerical and technical revisions appearing in supplement 7 include, but are not limited to the following specifically stated actions:

- (a) Repeal by implication of sections 105.010 to 105.470, inclusive, upon the effective date of Ordinance No. 1019 which date was June 15, 1998.
- (b) On December 10, 1996, the board of county commissioners passed Ordinance No. 970 which repealed sections 80.010 through 80.220 and enacted sections 80.010, 80.020, 80.030 and 80.040, the primary purpose of which was the creation of the department of community development, including therein, a division of building and safety, and repealing references to the department of comprehensive planning and the department of development review. Prior to adoption of Ordinance No. 970, the departments of comprehensive planning and development review were created in and referred to in chapter 110 of the Washoe County Development Code. While Ordinance No. 970 created the department of community development, including the creation of the position of director of the department, created the divisions and described the responsibilities of the department, Ordinance No. 970 was intended only to create the division of building and safety and to authorize appropriate changes to 110.914 and throughout the development code to remove references to the departments of comprehensive planning and development review and make appropriate references to the department of community development and division of building and safety. Accordingly, 110.914 and the development code were amended consistent with such authorization and thus the provisions of Ordinance No. 970 were not intended to create duplicate and conflicting references to the department of community development.

The board of county commissioners hereby ratifies the conforming amendments made to chapter 110 of the development code authorized by Ordinance No. 970, including the creation of the division of building and safety.

(c) On March 16, 1999, the board of county commissioners adopted Ordinance No. 1057 which repealed section 80.030, the provision in Ordinance No. 970 which created, among others the division of building and safety. The purpose of Ordinance No. 1057 was to create a separate department of building and safety

and to eliminate building and safety as a division of the department of community development. Ordinance No. 1057 also amended 110.914.05(f) of the development code to eliminate references to the division of building and safety.

The board of county commissioners hereby authorizes the department of community development to make all appropriate conforming amendments to the development code to reflect that as of the effective date of Ordinance No. 1057 (March 31, 1999) building and safety was no longer a division of community development but a separate department and to make appropriate division of duties between the department of community development and department of building and safety, where necessary, within the development code.

With these clarifications, the substantive provisions of the remaining sections 80.010, 80.020 and 80.040 are of no further force and effect.

(d) On July 22, 1997, the board of county commissioners adopted Ordinance No. 987 which made comprehensive amendments to the risk management provisions. On January 12, 1999, the board of county commissioners adopted Ordinance No. 1048 which made amendments to provisions of chapter 65 governing risk management and the county safety committee.

On March 16, 1999, the board of county commissioners adopted Ordinance No. 1055 to eliminate positions of assistant county manager for finance and assistant county manager for personnel and added provisions creating assistant county manager positions. On that same date, the board of county commissioners also adopted Ordinance No. 1058 creating the department of finance.

In drafting Ordinance Nos. 1055 and 1058 sections of chapter 65 were used which predated Ordinance Nos. 1048 and 987. Ordinance Nos. 1055 and 1058 were not intended to operate as repealing or amending previously enacted amendments to chapter 65 made by Ordinance Nos. 987 and 1048.

- (e) On March 16, 1999, the board of county commissioners adopted Ordinance Nos. 1055 (affecting assistant county managers); 1056 (affecting the manager's office); 1057 (affecting building and safety); 1058 (affecting the department of finance); 1059 (affecting emergency management); and 1060 (affecting the department of human resources). These ordinances implemented the reorganization approved by the board of county commissioners. These ordinances amended many of the same sections and were all written to stand alone. Codification of each of these ordinances reflects the passage of all the remaining ordinances and reflects the board's intention.
- 2. All actions heretofore taken are hereby validated, ratified, approved and confirmed.
