AN ORDINANCE AMENDING CHAPTER 60 OF THE WASHOE COUNTY CODE BY ADOPTING THE 1997 UNIFORM FIRE CODE WITH AMENDMENTS.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

SECTION 1. The Index for Chapter 60 of the Washoe County Code is hereby amended to read as follows:

 $\underline{\text{SECTION 3.}}$ Section 60.020 of the Washoe County Code is hereby amended to read as follows:

Uniform Fire Code

60.020 "Uniform Fire Code" defined. As used in sections 60.020 to 60.265 inclusive, "Uniform Fire Code" means Volumes 1 (Provisions and Appendices) and 2 (Standards) of the 1997 Edition of the Uniform Fire Code, published by the Western Fire Chiefs Association and the International Conference of Building Officials.

[Part §1, Ord. No. 193; A Ord. Nos. 348, 606, 786]

SECTION 4. Section 60.030 of the Washoe County Code is hereby amended to read as follows:

60.030 Uniform Fire Code: Adoption; penalty.

- 1. The 1997 Uniform Fire Code, copies of which have been placed on file in the office of the county clerk, together with such changes as made by sections 60.020 to 60.265, inclusive, are hereby adopted by reference, incorporated herein and made a part hereof, and shall regulate all matters contained therein.
- 2. Additional copies of the 1997 Uniform Fire Code may be requested from:
- (a) The Western Fire Chiefs Association, 300 N. Main Street #25, Fallbrook, CA 92028; or
- (b) The International Conference of Building Officials, 5360 Workman Mill Road, Whittier, CA 90601.
- 3. Any person violating any of the provisions of this chapter is guilty of a misdemeanor.
- [Part \$1, Ord. No. 193; A Ord. No. 348] + [Part \$4, Ord. No. 193]; [A Ord. Nos. 606, 786]

- SECTION 5. Chapter 60 of the Washoe County Code is hereby amended by adding a new section to read as follows:
- 60.035 1997 Urban-Wildland Interface Code: Adoption. The 1997 Urban-Wildland Interface Code (First Edition) published by the International Fire Code Institute, a copy of which has been placed on file with the office of the county clerk, is hereby adopted by reference, incorporated herein, and made a part hereof. With the exception of Section 105, this Code shall serve as a guide to establishing practices for the safeguarding of life and property.

SECTION 6. Section 60.040 of the Washoe County Code - NO CHANGE.

- 60.040 Enforcement; construction.
- 1. In those areas of Washoe County which lie within the boundaries of an organized fire protection district, the Uniform Fire Code may be enforced by the senior officer of the district. The terms "Fire Chief" or "Chief," as used in the Uniform Fire Code, refer to such senior officer or his authorized representative.
- 2. In those areas of Washoe County which do not lie within the boundaries of an organized fire protection district, the board of county commissioners may designate, by contract or otherwise, a person or entity empowered to enforce the provisions of the Uniform Fire Code. The term "bureau of fire prevention" shall mean the entity so designated. The term "Fire Chief" or "Chief" shall mean such person so designated by the board.
- 3. All references in the Uniform Fire Code to "municipality," "city" or similar terms shall be construed to mean Washoe County or fire protection district.
- 4. Wherever the word "jurisdiction" is used in the Uniform Fire Code, it shall mean the unincorporated area of Washoe County or fire protection district.

- SECTION 7. Chapter 60 of the Washoe County Code is hereby amended by adding a new section to read as follows:
- 60.045 Appeals: Section 103.1.4. Section 103.1.4 is amended by adding the following paragraph:

The fire chief shall have the power to modify any of the provisions of this chapter upon application in writing by the owner or lessee, or his duly authorized agent, when there are practical difficulties in the way of carrying out the strict letter of the code; provided, that the spirit of this title shall be observed, public safety secured and substantial justice done. The particulars of such modification when granted or allowed and the decision of the chief thereon shall be entered upon the records of the fire

department and a signed copy shall be furnished to the applicant.

SECTION 8. Chapter 60 of the Washoe County Code is hereby amended by adding a new section to read as follows:

60.047 <u>Changes in use of occupancy of buildings: Section</u>
103.3.2.3 <u>amended.</u> Section 103.3.2.3 of the Uniform Fire Code is amended by adding the following sentence:

No change shall be made in the character or use of any building unless such building is made to comply with reasonable fire safety standards as approved by the Fire Chief or his authorized representative.

SECTION 9. Section 60.070 of the Washoe County Code is hereby amended to read as follows:

60.070 Compliance with orders, notices and tags: Section 103.4.3.1 amended. Section 103.4.3.1 is hereby amended by adding the following paragraphs:

Whenever the Chief or his duly authorized representative finds a fire hazard existing on any lot, sidewalk, parkway or other property, public or private, the Chief or his authorized representatives may issue and serve a Notice to Abate upon the responsible party requiring abatement of such fire hazard. Such notice shall be in legible characters, shall set forth the violation and shall direct the abatement of the fire hazard within a specified time, not to exceed 30 days from the date of service.

The owner, the agent of the owner, or the person in possession of any lot or premises upon which the Notice has been served shall abate such fire hazard within the time specified. If the person fails or neglects to abate the fire hazard within the time specified, the Chief or his authorized representative may cause a complaint to be filed with the county clerk by requesting the board of county commissioners to commence appropriate civil abatement proceedings as provided in NRS 244.360. Alternatively, the Chief or his authorized representative may request a peace officer to issue a criminal citation in the justice's court in the township where the property is located.

Any remedies or powers provided herein are in addition to or alternatives to any other powers of the county to abate nuisances and fire hazards.

SECTION 10. Section 60.150 of the Washoe County Code is hereby amended to read as follows:

60.150 Fire extinguishing systems: Required installations Section 1003.2.1 amended.

Section 1003.2.1 is hereby amended by adding the following:

1. New Buildings Exceeding 5,000 Square Feet. All buildings (except Group R-3, Dwellings) constructed after November 1, 2001 with more than 5,000 square feet in floor area, shall have an automatic fire detection or fire extinguishing system installed throughout and shall be connected to a supervising fire alarm company.

Exceptions:

- (a) When not required by other provisions of the adopted codes and ordinances, a fire detection or fire extinguishing system may be omitted when a property line condition, which divides the building into sections not greater than 5,000 square feet, is established. Exterior wall construction criteria, without openings, shall meet the specifications of Chapter 5 of the Uniform Building Code.
- (b) In Group S-1 Ministorage Occupancies, a fire alarm or fire extinguishing system is not required when area separation walls are provided within the building to ensure that no portion of the building is greater than 5,000 square feet in area.
- 2. Existing Buildings Exceeding 10,000 Square Feet. All buildings constructed before November 1, 2001 with more than 10,000 square feet in floor area, shall have automatic fire detection or automatic fire extinguishing system throughout and shall be connected to a supervising station fire alarm company. Exceptions:

(a) Private one and two family dwellings.

60.215 Definitions: Sections 207-F, 209-H and 213-L amended.

1. Section 207-F of the Uniform Fire Code is amended by adding the following paragraph to the definition of "fire hazard".

Cultivated and useful grasses and pastures shall not be declared a fire hazard except that if the Chief or his authorized representative determines it to be necessary to protect adjacent improved property from fire exposure, an adequate fire break may be required as specified in Appendix II.

- 2. Section 209 H of the Uniform Fire Code is amended by adding the following sentence to the definition of "hotel" to provide:
 - "This definition shall also describe and include motel."
- 3. Section 213-L of the Uniform Fire Code is amended to add to the definition of Lumber Yard, a lot used for the storage or sale of lumber used for construction, firewood, or wooden pallets.
- SECTION 16. Chapter 60 of the Washoe County Code is hereby

amended by adding a new section to read as follows:

60.220 Fire department access and water supply: Sections 901.4.4; 902.2.4 and 903.4.2.

- 1. Section 901.4.4 of the Uniform Fire Code is amended by including the following sentence. Commercial addresses shall be a minimum of 6 inches in height with a stroke of not less than $\frac{3}{4}$ inch.
- 2. Section 902.2.4 is amended to include the following section:
 Section 902.2.4.3 Obstruction. It shall be a code infraction subject to a fine when, any person parks a vehicle or otherwise obstructs a fire lane, provided that the access roadways have been identified by means approved by the Fire Chief. Signs shall indicate "NO PARKING - FIRE LANE." The Fire Chief may require curbing on fire lanes to be painted red.
- 3. Section 903.4.2 is amended by deleting the second sentence.
- SECTION 17. Chapter 60 of the Washoe County Code is hereby amended by adding a new section to read as follows:
- 60.225 Fire protection systems and equipment: Sections 1001.5.6 and 1001.5.7 added.
- Section 1001.5 is amended to include the following section:
 Section 1001.5.6 - Owner's Responsibility to Maintain Smoke Detectors and Class II Standpipes.
- (a) It is the responsibility of building owners to maintain systems and detectors required by this Code. It is unlawful for any owner or operator to refuse to install or maintain such systems. Records of maintenance and repair shall be kept onsite.
- (b) When smoke detectors required by the Uniform Building Code for residential occupancies are found to be non-operational on two or more inspections, they shall be replaced with smoke detector units wired into an electrical outlet using wire mold or conduit and having a battery back-up power supply.
- (c) Class II standpipes shall be inspected annually to certify the hose, nozzle and valve operation.
- 2. Section 1001.5 is amended to include the following section.

Section 10001.5.7 - Maintenance of Inspection Records. All required fire alarms, fire suppression and commercial kitchen hood ventilation systems shall be maintained in accordance with the Nevada State Fire Marshal's Regulations. Air systems for fire suppression breathing apparatus shall be maintained at the same frequency as other high-rise life safety systems, and procedures for maintenance and report records shall be approved by the inspecting fire authority. Inspection records shall be kept on-site and shall be readily available. When a serious deficiency is found with an air system for fire suppression breathing apparatus, fire alarm, fire suppression or commercial kitchen hood ventilation system, the fire prevention bureau shall be notified immediately.

- SECTION 18. Chapter 60 of the Washoe County Code is hereby amended by adding a new section to read as follows:
- 60.230 Fire protection systems and equipment: Section 1002.2 amended.

Section 1002.2 is amended to include the following sentence: The use and sale of portable Halon fire extinguishers are prohibited except as approved for use in commercial occupancies and special applications by the fire department.

- SECTION 19. Chapter 60 of the Washoe County Code is hereby amended by adding a new section to read as follows:
- 60.235 Fire protection systems and equipment: Sections 1003.1.2 and 1003.3.1 amended.
 - 1. Section 1003.1.2 is amended by revising the introductory sentence to read as follows:

Fire-extinguishing systems shall comply with the most current edition of the National Fire Protection Association Codes and Standards as referenced in the Uniform Building Code - Standard 9-1.

- 2. Section 1003.3.1 is amended to read as follows:
- 1003.3.1 Where required. All valves controlling the water supply for automatic sprinkler systems and water-flow switches on all sprinkler systems shall be electrically monitored where the number of sprinklers are twenty (20) or more in all occupancies.

Valve monitoring and water-flow alarm and trouble signals shall be distinctly different and shall be automatically transmitted to an approved central station, remote station or proprietary monitoring station as defined by

UFC Standard 10-2 or, when approved by the building official with the concurrence of the chief, shall sound an audible signal at a constantly attended location.

EXCEPTION: Residential Group R-3 and U-1 occupancies.

SECTION 20. Chapter 60 of the Washoe County Code is hereby amended by adding a new section to read as follows:

60.240 Fire protection systems and equipment: Sections 1007.1.2; 1007.2.12.2.1; 1007.3.3.6.1 amended.

1. Section 1007.1.2 is amended by adding the following

paragraphs:

(a) False alarm due to service company. Emergency fire department response due to failure of fire sprinkler/suppression company personnel to notify the fire department via a central station fire alarm provider when servicing/testing such systems, shall be subject to a 150.00 service charge for each occurrence.

- (b) False alarm due to owner/occupant. Emergency fire department response caused by lack of system maintenance, building employees or other personnel causing alarms due to the nature of their work, and failure by the building operator to make proper notification to the fire department via a central station fire alarm provider shall be subject to a \$150.00 service charge for each occurrence.
- 2. Section 1007.2.12.2.1 is revised to read as follows: Group B office buildings and Group R, Division 1 Occupancies, each having floors used for human occupancy located more than 55 feet above or below the lowest level of fire department vehicle access, shall be provided with an automatic fire alarm system and a communication system in accordance with Section 1007.2.12.2.
- 3. Section 1007.3.3.6.1 is revised by adding the following paragraph:
 Monitoring of fire alarm systems must be done locally.
 Monitoring services located outside the local area are permitted only when a central station serving the local area, that has been previously approved by the fire chief, is also monitoring the fire alarm system.
- SECTION 21. Chapter 60 of the Washoe County Code is hereby amended by adding a new section to read as follows:
- 60.245 General safety precautions; Section 1109.8.1 and 1110.3 amended.

- 1. Section 1109.8.1 is amended by adding the following sentence:
- It is unlawful to use open flame devices for pipe thawing without first obtaining a special use permit from the fire department.
- 2. Section 1110.3 is amended by adding the following paragraph: All commercial buildings, within one week of vacancy/closure, shall have a security plan approved by the fire department. All security plans shall be reviewed and renewed every six (6) months.
- SECTION 22. Chapter 60 of the Washoe County Code is hereby amended by adding a new section to read as follows:
- 60.250 Maintenance of egress and emergency escape: Sections 1211.1 and 1212.4 amended.
- 1. Section 1211.1 is amended by adding the following paragraph:
 In addition to the requirements found in Section 1003.2.9.2 of the Uniform Building Code, all egress illumination shall be of the emergency battery pack type, and shall be installed even though emergency generators are provided on site.
- 2. Section 1212.4 is amended by adding the following paragraph: In addition to the requirements found in Section 1003.2.8.4 of the Uniform Building Code, all exit signs shall be internally illuminated and shall be of the emergency battery pack type, and shall be installed even though emergency generators are provided on site.
- SECTION 23. Chapter 60 of the Washoe County Code is hereby amended by adding a new section to read as follows:
 - 60.255 Places of assembly; Section 2505.2.3.2 amended.

Section 2505.2.3.2 is amended to be revised to read as follows:
Quantity limit. Fuel in fuel tank shall not exceed one-quarter the tank capacity.

- SECTION 24. Chapter 60 of the Washoe County Code is hereby amended by adding a new section to read as follows:
- 60.260 Wood products; Section 3003 and 3009.2 amended.

 1. Section 3003 is amended to be revised to read as follows:
 For a permit to store more than 50 cords of firewood, see Section 105, Permit, w.1.

2. Section 3009.2 is amended by adding the following paragraph:

Piles for pallets shall have a maximum height of 10 feet. Firewood shall be piled with due regard to stability of the piles and in no case higher than 10 feet. Where firewood is piled next to a property line on which a building has been erected, the distance from the pile to the property shall be no less than one half the height of the pile and in no case less than 5 feet.

SECTION 25. Chapter 60 of the Washoe County Code is hereby amended by adding a new section to read as follows:

60.265 Appendices; adoption.

- (a) Appendix I-A: Life Safety Requirements for Existing Building Other than High Rise. Section 1.2 Effective Date is Deleted.
- (b) Appendix I-C: Stairway Identification -Section 2. General. Section 2 of Appendix I-C is amended by adding the following paragraph:

A sign approved by the fire department shall be located on each side of all doors leading to all enclosed stairways of buildings 4 or more stories in height. The signs on the doors leading to stairways with roof access shall be red. The sign shall be located approximately 5 feet above the floor. For buildings less than 4 stories, the sign shall comply with the following:

- (i) Only the floor number is required to be indicated.
 - (ii) The green and red color code system shall be used.
 - (iii) The numbers shall have a minimum height of four
- (4) inches.
- (c) Appendix III-A: Fire Flow Requirements for Buildings.
 - (i) Section 1 of Appendix III-A is revised to read as follows:

 The procedure for determining fire-flow requirements for buildings or portions of buildings hereafter constructed shall be in accordance with Appendix III-A as revised and amended.
- (ii) Table A-III-A-1 is replaced with the following table:

Type of Land Development	Required Fire Flow in Gallons Per Minute
 Detached single family, duplex or triplex residential occupancies. 	1,000 GPM (includes automatic sprinkler system flows)

2. Neighborhood commercial properties with single story buildings that have complete automatic sprinkler systems, multi-family residential occupancies of four or more including townhouses, condominiums or apartments. Zero-lot line developments shall be considered as attached units for determining the number of units per building.

2,000 GPM (includes automatic sprinkler system flows) available to the proposed development.

3. Neighborhood commercial not included above, other commercial, industrial, institutional, public uses or any high-rise structure including the principal business districts, focal points and major retail centers.

3,000 GPM (includes automatic sprinkler system flows) available to the proposed development.

4. High fire hazard occupancies, includes: all warehouse occupancies covered by UFC Article 81, "High-piled Combustible Storage," all occupancies classed as H-1, H-2 and H-3 (see UBS Section 307); and those occupancies determined by the fire department to have a severe fire hazard due to the fuel load or significant exposure risk.

Fire flow shall be calculated by using the UFC Appendix III A**, but never shall available fire flow be less than 3,000 GPM.

- ** A reduction up to a maximum of 50% in the required fire flow as referenced in Appendix III-A, may be approved by the fire department in buildings that have a complete automatic fire sprinkler system.
 - (d) Appendix IV-B: Christmas Trees

Section 2 of Appendix IV-B is amended by adding the following sentence:

When a tree meets the requirements of this Appendix, no permit is required.
