THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

<u>SECTION 1.</u> Chapter 55 of the Washoe County Code is hereby amended by adding thereto a new section which shall read as follows:

55.090 <u>Wadsworth and Stampmill Estates Subdivision: Congested area.</u> The following described area within the unincorporated area of the county is determined to be a congested area: All that certain area within the following described parcels of land within the unincorporated area of Washoe County: The NW ¼ of section 3, the NE ¼ of section 4, the NW ¼ of section 8 and all that portion of the SW ¼ of section 8 lying northwesterly of the I-80 right-ofway, all in T. 20 N., R. 24 E., M.D.B.&M.
