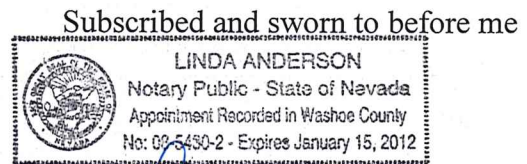

That the Regional Road Impact Fee Capital Improvement Plan is hereby amended as set forth in Exhibit A which is attached and incorporated by reference.


