AN ORDINANCE AMENDING CHAPTER 25 OF THE WASHOE COUNTY CODE (BUSINESS LICENSES, PERMITS AND REGULATIONS) BY ELIMINATING THE REQUIREMENT TO SET ASIDE 40% OF THE BUSINESS LICENSE FEES ON PUBLIC UTILITIES PROVIDING ELECTRIC ENERGY SERVICE AND TELECOMMUNICATION SERVICE FOR USE IN UNDERGROUNDING UTILITY LINES EXISTING AS OF JULY 24, 2001 AND OTHER MATTERS PROPERLY RELATED THERETO

SECTION 1. Section 25.509 of the Washoe County Code is hereby repealed:
