AN ORDINANCE AMENDING THE WASHOE COUNTY CODE Chapter 110, Development Code, Article 406, Building Placement Standards, to increase the density for Manufactured Home Parks within the Medium Density Suburban (MDS) and Medium Density Suburban 4 (MDS 4) regulatory zones for all areas within Washoe County previously designated Trailer Overlay (TR) zoning and providing other matters properly relating thereto.
