SUMMARY: An ordinance amending the Washoe County Code by adding a new section to Chapter 50 for the regulation of fireworks.

AN ORDINANCE AMENDING CHAPTER 50 OF THE WASHOE COUNTY CODE BY ADDING THERETO PROVISIONS FOR THE PROHIBITION OF THE USE OF FIREWORKS WITHOUT LICENSE, EXEMPTIONS, AND SEIZURE AND PENALTIES FOR VIOLATION, AND PROVIDING OTHER MATTERS PROPERLY RELATED THERETO.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

SECTION 1. Chapter 50 of the Washoe County Code is hereby amended by adding thereto the provisions set forth in sections 2 to 6.

SECTION 2.

FIREWORKS

50.280. Definitions. For the purpose of sections 50.280 to 50.290, inclusive, and unless otherwise indicated in those sections, the definitions of the words and phrases in Chapter 33 of the county adopted version of the International Fire Code, apply to the construction and interpretation of sections 50.280 to 50.288.

SECTION 3.

50.282. Conflict of Codes. For the purpose of sections 50.280 to 50.290, where a provision is in conflict with any other fire safety law, the most stringent or restrictive, or as applicable the higher standard for the promotion and protection of the health and safety of the people, shall prevail.

SECTION 4.

50.284 No Discharge, Storage; Seizure; License. No person may possess, use, store, or discharge fireworks or other materials with a pyrotechnic composition of any class within the boundaries of the unincorporated county unless that person is licensed by the Nevada State Fire Marshal as an assistant pyrotechnic operator or a pyrotechnic operator pursuant to Nevada Administrative Code sections 477.622 to 477.628, inclusive, and satisfies any applicable permit requirements in the county adopted version of the International Fire Code. The terms "assistant pyrotechnic operator" and "pyrotechnic operator" shall be as described in Nevada Administrative Code sections 477.622 through 477.628, inclusive. The possession, storage, or sale, offer or exposing for sale of fireworks or pyrotechnic materials of any class without an appropriate Nevada State Fire Marshal license or without an appropriate local fire agency permit, shall be considered an intent to discharge fireworks or pyrotechnic materials and the fireworks or pyrotechnic materials shall be subject to seizure, removal, abatement or cause for removal or abatement, and forfeiture, without notice pursuant to either one or a combination of chapter 125 of the county code, NAC 477.661, and NRS 202..750 through 202.840, inclusive.

SECTION 5.

50.286. Exemptions. The provisions of sections 50.282 and 50.290 do not apply to:

- 1. Arms and handguns regulated by 18 U.S.C. §§ 921 et seq.
- 2. Activities conducted by the United States Department of Defense or by a contractor of the Department of Defense in connection with the transportation of, or experimentation on, missiles and rockets.
- 3. Paper caps containing less than 0.25 grain of pyrotechnic composition per unit load.
- 5. Tracer bullets or charges that are used at a qualified rifle or shotgun range or by military or naval personnel or peace officers.
- 5. Devices for signals used in connection with the operation of railroads or other forms of transportation.
- 6. The use, after purchase at retail, of fireworks which are designed and intended by the manufacturer for the prevention of damage to crops or the unwanted occupancy of areas by animals or birds through the use of sound or light, or both.

SECTION 6.

50.288. <u>Fireworks Display.</u> The display of fireworks shall comply with applicable provisions of Nevada Administrative Code 477.571 et seq.

SECTION 7.

50.290. Violation; Penalties; Abatement. Persons who violate any provision of sections 50.282 to 50.288, inclusive, who fail to comply with any requirements thereof, or who violate any permit or directive of the fire code official issued thereunder, is guilty of a misdemeanor. Each day that a violation continues after due notice has been served shall be deemed a separate offense. In lieu of criminal prosecution and penalties, the fire code official may institute appropriate remedies and action pursuant to Chapter 125 of the county code or NAC 477.661 to prevent or correct violations.
