SUMMARY: An ordinance establishing the boundaries of a district for a surcharge on the rental of hotel rooms.

BILL NO. <u>1747</u> ORDINANCE NO. *1565*

AN ORDINANCE AMENDING CHAPTER 25 OF THE WASHOE COUNTY CODE (BUSINESS LICENSES, PERMITS AND REGULATIONS), ADDING SECTION 25.1515 (BOUNDARIES OF CERTAIN DISTRICTS) TO ESTABLISH THE BOUNDARIES OF A CERTAIN DISTRICT FOR THE IMPOSITION OF A SURCHARGE ON HOTEL ROOM RENTALS AS REQUIRED BY S.B. 312; AND PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

<u>SECTION 1.</u> S.B. 312 passed by the 78th Nevada Legislature and signed by the Governor creates a new district for the promotion of tourism and imposes a new \$2 surcharge on the per night charges for the rental of a room in a hotel in the district. Section 4 of the bill requires the Washoe County Board of County Commissioners to adopt an ordinance prescribing the boundaries of the district and describes what property must be included within its boundaries.

<u>SECTION 2.</u> Chapter 25 of the Washoe County Code (Business Licenses, Permits and Regulations) is hereby amended by adding section 25.1515 which shall read as follows:

25.1515 Boundaries of Certain Districts.

- 1. For the purposes of this section:
- (a) "Hotel" means a building occupied or intended to be occupied for compensation, as the temporary residence for transient guests, primarily persons who have residence elsewhere; and
- (b) A hotel has an interior hall and lobby with access to each room from the interior hall or lobby.
- 2. The boundaries of the district for the imposition of a per night surcharge for the rental of a room in a hotel includes all property:
- (a) which is located in the county and located in any city in the county other than property that is located within a district created by a city to finance capital projects necessary to improve and maintain publicly owned facilities for tourism and entertainment; and
- (b) which is located not more than 20 miles from the boundaries of any such district created by a city; and
- (c) which does not include any property located within a district created pursuant to NRS 268.798.

<u>SECTION 3.</u> If any section of this ordinance or portion thereof is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such holding shall not invalidate the remaining parts of this ordinance.

<u>SECTION 4.</u> All ordinances, parts of ordinances, chapters, sections, subsections, clauses, phrases, or sentences contained in the Washoe County Code in conflict herewith are hereby repealed.

<u>SECTION 5.</u> This ordinance shall be published by title only, together with the names of the County Commissioners voting for or against its passage, in a newspaper published in and having a general circulation in Washoe County, Nevada, at least once a week for a period of two (2) weeks, and shall be in force and effect on August 21, 2015 and thereafter.
