### **Speakers**

**Laura Knight, MD** is the Chief Medical Examiner and Coroner at the WCRMEO. A board-certified forensic pathologist with over 15 years of experience, she is also an Associate Professor in Pathology and Pediatrics at the University of Nevada, Reno School of Medicine, a fellow of the National Association of Medical Examiners (NAME), served on the Board of Directors of NAME, served on the National Panel on Sudden Unexplained Deaths in Pediatrics as a committee Chair, and is a current member of the NIST/DOJ Organization of Scientific Area Committees in the area of medicolegal death investigation. She is the current Chair of the Nevada Committee to Review Suicide Fatalities and the Nevada State Disaster Identification Coordination Committee. Dr. Knight has special interest in infant and child deaths, suicide prevention, organ/tissue donation, and mentoring medical students and future forensic pathologists.

Clare Bryce, MD is the Deputy Chief Medical Examiner at the WCRMEO. She is a board-certified forensic pathologist and neuropathologist with over 15 years of experience. She is an adjunct Associate Professor at the Icahn School of Medicine at Mount Sinai in New York and serves on several national committees. She is also the Nevada Delegation Chair of the College of American Pathologists House of Delegates. Dr. Bryce has a special interest in neuropathology and natural disease processes at autopsy.

**Marin Pilloud, PhD** is a board-certified forensic anthropologist (D-ABFA) who examines skeletonized remains at the WCRMEO. She is an Associate Professor in the Anthropology Department at the University of Nevada, Reno, and the Graduate Program Director, overseeing graduate students in forensic anthropology and bioarchaeology research projects across the globe. She obtained her PhD from Ohio State University, and is a fellow of the American Association of Forensic Sciences. Dr. Pilloud

is the current president of the Dental Anthropology Association, and her research interests focus on how the human skeleton can inform the understanding of human behavior in archeological contexts and can be used in the forensic context as part of the biological profile; and on the application of dental morphology and metrics to furthering knowledge in both bioarchaeology and forensic anthropology.

**Henry McNett, MD** is an Assistant Medical Examiner at the WCRMEO. He is a board-certified forensic pathologist with 5 years of experience. He obtained his M.D. from Oregon Health and Sciences University, completed pathology residency training at Washington University, and completed forensic pathology fellowship training at the University of New Mexico. Dr. McNett is an Assistant Professor in Pathology at the University of Nevada-Reno School of Medicine. He has special interest in toxicology and cardiac pathology.

William Sago, MD is an Assistant Medical Examiner at the WCRMEO. He is a board-certified forensic pathologist with 5 years of experience. He obtained his M.D. from Meharry Medical College, and completed pathology residency training and forensic pathology fellowship at University of Tennessee Health Science Center in Memphis, Tennessee. Dr. Sago is an Assistant Professor in Pathology at UNR School of Medicine. Dr. Sago has special interest in traumatic injuries and forensic toxicology.

**Irfan Chaudhry, MD** is an Assistant Medical Examiner at the WCRMEO. He is a board-certified forensic pathologist with 4 years of experience. He obtained his M.D. from St. Georges University, completed pathology residency training at Los Angeles County/Harbor-UCLA, and completed forensic pathology fellowship training at King County Medical Examiner's Office/University of Washington.
