(1) Consistency with Master Plan. The proposed amendment is in substantial compliance with the policies and action programs of the Master Plan.

RE: The subject parcel is entirely in Rural Residential (RR). In Jurisdiction 3, Plan area "SW." All neighboring parcels are of the same Rural Residential Master plan designation.

(2) Compatible Land Uses. The proposed amendment will provide for land uses compatible with (existing or planned) adjacent land uses, and will not adversely impact the public health, safety or welfare.
