Dear Commissioners:

The Coalition for Nevada's Wildlife (Coalition) hereby expresses our serious concerns over the proposed drone testing and use of explosives associated with the above referenced Special Use Permit. The Coalition is the issue, policy, and lobbying arm of sportsmen in northern Nevada dedicated to the protection and enhancement of the state's wildlife resources. Our directors are typically past and present presidents or directors of the major sportsman/wildlife conservation organizations representing tens of thousands of northern Nevada sportsmen. We represent fishing, big game, waterfowl, upland game, trapping, sporting dog, and predator hunting interests.

The history of wildlife in Nevada is one of decimation through over-exploitation that resulted in the eradication of our big game species. It is only in the past few decades that the partnership of private sportsmen and the Nevada Department of Wildlife (NDOW) has reintroduced, augmented, and brought back thriving population of bighorn sheep, antelope, mule deer, and a multitude of smaller species to this region. Sportsmen have contributed tens of millions of dollars and tens of thousands of volunteer man-hours to these efforts across the state, which are recognized as the most ambitious and successful big game reintroduction programs in North America!

Game Management area 014, which encompasses the Iverson Ranch, is a great example of our efforts and success. Bighorn sheep now populate the mountains for the first time in over a century. Antelope, once nearly gone, are numerous. Mule deer and sage grouse have recently declined due to wildfire, drought, and predation, but are now targets of concentrated mitigation measures that are showing success. For example, NDOW is reseeding large areas previously burned just a few miles south of the Iverson ranch; this project will be continued for the next 5 years or so. NDOW has also captured and placed GPS collars on mule deer to study areas of seasonal use, migration corridors, and survival rates. Water resources are being enhanced. Predator control has been initiated to allow bighorn sheep

and mule deer recovery. All the efforts are paid for by sportsmen's dollars. The Granite mountains of Area 014 have for many years been the "Holy Grail" for sportsmen trying to draw a coveted mule deer tag.

Wildlife species such as sage grouse are very sensitive to noise. Recent evidence collected by NDOW in central Nevada has shown that even an audible hum from a recently constructed geothermal power plant has displaced sage grouse populations over 2 miles away. This bird which is on the brink of being listed as "Threatened or Endangered" does not simply relocate, entire populations go away! Big game species make it through the cold winter months using up their fat reserves put on during late summer and fall months; they only have so much energy available. Any stress on these animals decreases their survival rate in harsh winters.

The proposed project flies in the face of our efforts and accomplishments. Five to ten low altitude drone flights per day with added chase aircraft, not just over private property but also over our public lands are being proposed. The noise from drones is an obnoxious buzz that will stress and disrupt wildlife. The ordinance detonation and engine testing are not currently deemed detrimental, if the noise levels stated by the proponents are monitored and verified. Wildfires being started is a very real potential from the inevitable drone crashes so that response planning and funding requirements are necessary. Full restoration costs should be borne by the proponent with appropriate bonding.

The operations proposed in this Special Use Permit are a direct threat to the efforts of Nevadans to restore our wildlife resources. This proposal should either be rejected or heavily conditioned to include at least the following:

- 1) Drone flights should be restricted to airspace above private property,
- 2) Drone flights should be prohibited during critical wildlife periods such as sage grouse breeding, and fawning of mule deer, antelope and bighorn sheep,
- 3) A wildfire protection plan should be formulated for approval with all costs borne by the proponent with adequate assurance bonding for suppression and restoration.

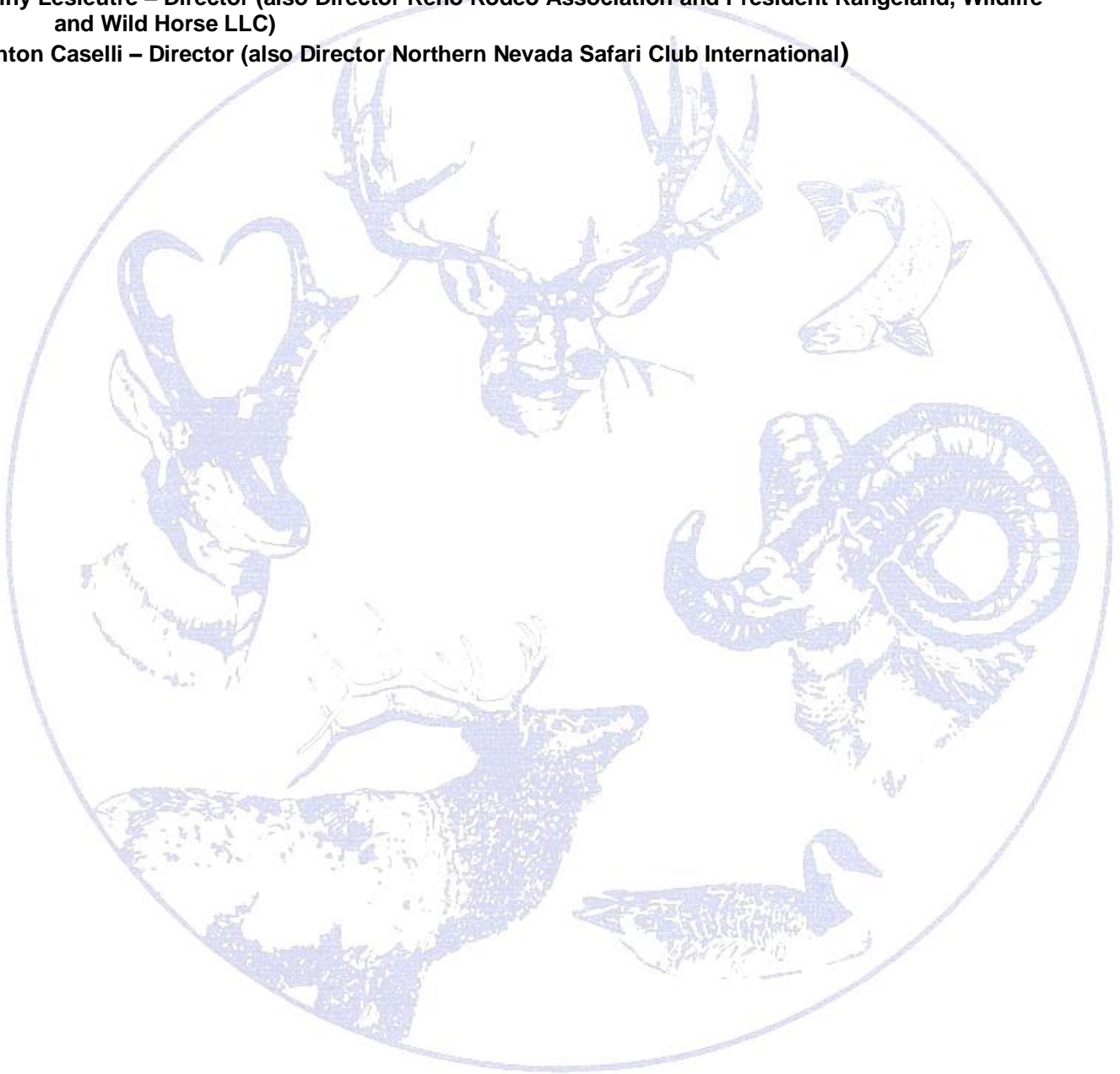

Dear Commissioners,

The Friends of Black Rock–High Rock appreciate the opportunity to provide input on the Iverson Ranch Special Use Permit (SUP).

Friends of Black Rock-High Rock is a nonprofit organization dedicated to protecting, stewarding, and sharing the unique landscapes, wildlife, culture, and recreation opportunities of the Black Rock Desert–High Rock Canyon region. We operate a visitor center in Gerlach, where we provide maps, regional information, nature walks, and art tours, and teach responsible recreation using Leave No Trace principles.

This year, we organized four multi-day campouts that allowed participants to immerse themselves in the Black Rock–High Rock region while learning about its ecology, history, and cultural significance. We also organized stewardship projects that attracted volunteers who worked on habitat restoration and cleanup efforts across the region. We partner with Fly Ranch, a unique property adjacent to the Black Rock Desert and approximately 6 miles from Iverson Ranch, where we guide nature walks for visitors. Fly Ranch has become an important educational and community resource, attracting visitors who seek quiet reflection, connection with nature, and learning opportunities about conservation and sustainability.

Our Concerns

Visitors come to the Black Rock–High Rock region seeking quiet solitude and abundant wildlife. The high-pitched, continuous buzzing of drone rotors will degrade this experience and disrupt wildlife viewing opportunities. We are also concerned about explosive detonations and their potential impacts on local wildlife, as well as wildfire risks associated with drone crashes and explosive materials. Additionally, we have significant concerns about potential future expansion plans.

Our Recommendation

We respectfully request that the SUP be denied. If the permit is approved, we strongly recommend the following conditions:



FRIENDS OF BLACK ROCK HIGH ROCK

1. Sound Monitoring and Reporting at the Iverson Ranch property line, Hwy 34, nearest residence, and Fly Ranch. (monitored by an independent organization)
2. Groundwater Monitoring Well for contamination surveillance (monitored by an independent organization).
3. Public Feedback Channel for reporting/viewing noise monitoring data, Iverson operational notices, and logging concerns or complaints (administered by an independent organization)
4. Drone Flight Restrictions limiting flights to Iverson property only, and prohibiting flights over Wilderness areas.
5. Geo fences around sensitive areas and private property.

Thank you for considering our concerns. We look forward to working collaboratively to ensure the protection of this unique and fragile landscape.

Dear Commission Members:

Northern Washoe County has always been proud to offer pristine habitat that is utilized by numerous species of wildlife. As Nevadans we take pride in being responsible stewards of this habitat. Nevada Bighorns Unlimited is one of the largest conservation Non Government Organizations (NGOs) in Nevada representing sportsmen/women to enhance wildlife across our state.

Mr. Mike Arth did a very thorough job of presenting this material last Thursday evening at the Gerlach Citizen's Advisory Board. We respect his clarity and willingness to foster discussion. We have to find a good balance between innovation, technology and businesses that seeks to help Nevada be a leader in commerce across the west. Our state wildlife should not suffer due to our commercial ambitions. Our concerns with the proposal from Iveson Ranch focus on the disruption and impact on the adjacent wildlife populations.

-Noise aversion: this affects all species of wildlife as well as the cattle and ranching industry of the area.

-drone flights over critical habitat that includes lambing/calving/fawning grounds as well as neonate rearing grounds. These areas should be as stress free as possible and free from pressures that we know directly impact survival of these young animals.

-continuous small energetics explosions will drive wildlife from natural preferred habitat.

We propose

1. Restricted flight pathways and corridors to mitigate this.
2. Restrictions on flight paths during sensitive timing for wildlife (lambing seasons, neonates, breeding...etc)

-Concerns for Future expansion: we understand that the business of the ownership of Iveson ranch may not be able to divulge certain information pertaining to the work and research they are performing at their private property. Our concerns lie in the fact that this may be a subtle initial push that may be greatly expanded in the future. We recommend careful considerations of removal of county ordinances/regulations that would "let the genie out of the bottle" and we would be unable (or unwilling) to combat that down the road...

How does the approval of this Special Use Permit benefit Washoe county? Its residents? The land and the associated wildlife that depend on the health of the ecosystem?

Nevada Bighorns Unlimited strongly opposes this special use permit. The impacts to the neighboring wildlife and habitat have not been fully evaluated and addressed. It would be irresponsible to approve this permit as presented.

Subject: Drone and Explosives Testing at the Iveson Ranch (WSUP25-0018)

Dear Planning Commission and Staff,

Please accept the following comments and concerns provided on behalf of Bright Holland Co and BBB Investments LLC, who own considerable property in the vicinity of the proposed drone and explosives testing project.

My clients support economic development in the Gerlach and Hualapai Valley area, but are concerned that this project could significantly impact and devalue other property in the area.

There is a long history of conservation efforts in the Hualapai Valley and Granite Mountains. In the 2000's, Bright Holland sold large blocks of nearby land to the BLM so it could be used for conservation purposes. In the 2010's, the BLM updated their resource management plan to designate a special recreational management area (SRMA) extending from Granite Mountain into Hualapai Valley. In the 2020's, Senator Rosen worked with local agencies and stakeholders on the Truckee Meadows Lands Bill. The bill introduced in the Senate would further protect the SRMA with formal designations of Wilderness and Mineral and Leasing Withdrawal (see attached maps).

Most of Bright Holland's nearby parcels are unfenced and interspersed with the BLM recreation areas. Parcels are currently used mostly for recreational purposes, consistent with the approved plans for the area. Other parcels have been sold and developed with homes. If the county approves impactful drone and explosives testing, Bright Holland's remaining parcels will be devalued and may no longer be usable for recreational and residential uses. Wildlife and public land impacts would also be significant.

This project may be more appropriate on a larger remote parcel or in areas that already have military facilities and heavy industrial uses.


If this project is to proceed, the County should better address overflight limitations, noise, and groundwater contamination.

- Overflight Limitations. Detailed flight areas should be established for any use of drones beyond the project's private parcel boundaries. Such flight paths should provide a reasonable buffer (1/4 - 1/2 mile) from other private parcels and from the BLM designated special recreational management area. Wildlife agency concerns should also be addressed.

- Noise limitations. Staff appears to be supporting a complete waiver of the County noise ordinances. Explosives testing areas should be located and designed in accordance with adopted noise limitations. At a minimum, a 65 dB noise limit should be applied and monitored at a specified distance ($\pm 1/4$ mile) from the project boundary. Noise can echo and reverberate in areas like this. Reasonable conditions would keep impacts localized.
- Groundwater Contamination: We appreciate that groundwater monitoring wells are recommended to detect contamination from the project and the likely migration of contaminated groundwater contamination to other properties. We think that requirement should be supplemented with containment and soil testing requirements for the explosives testing location. The project should be required to regularly test soils and remove any contaminated soil before the pollutants reach the groundwater table. We do not need another situation like the Rocketdyne contamination in Palamino Valley. That pollution was caused by a similar facility and continues to impact nearby properties many decades after the testing was discontinued.

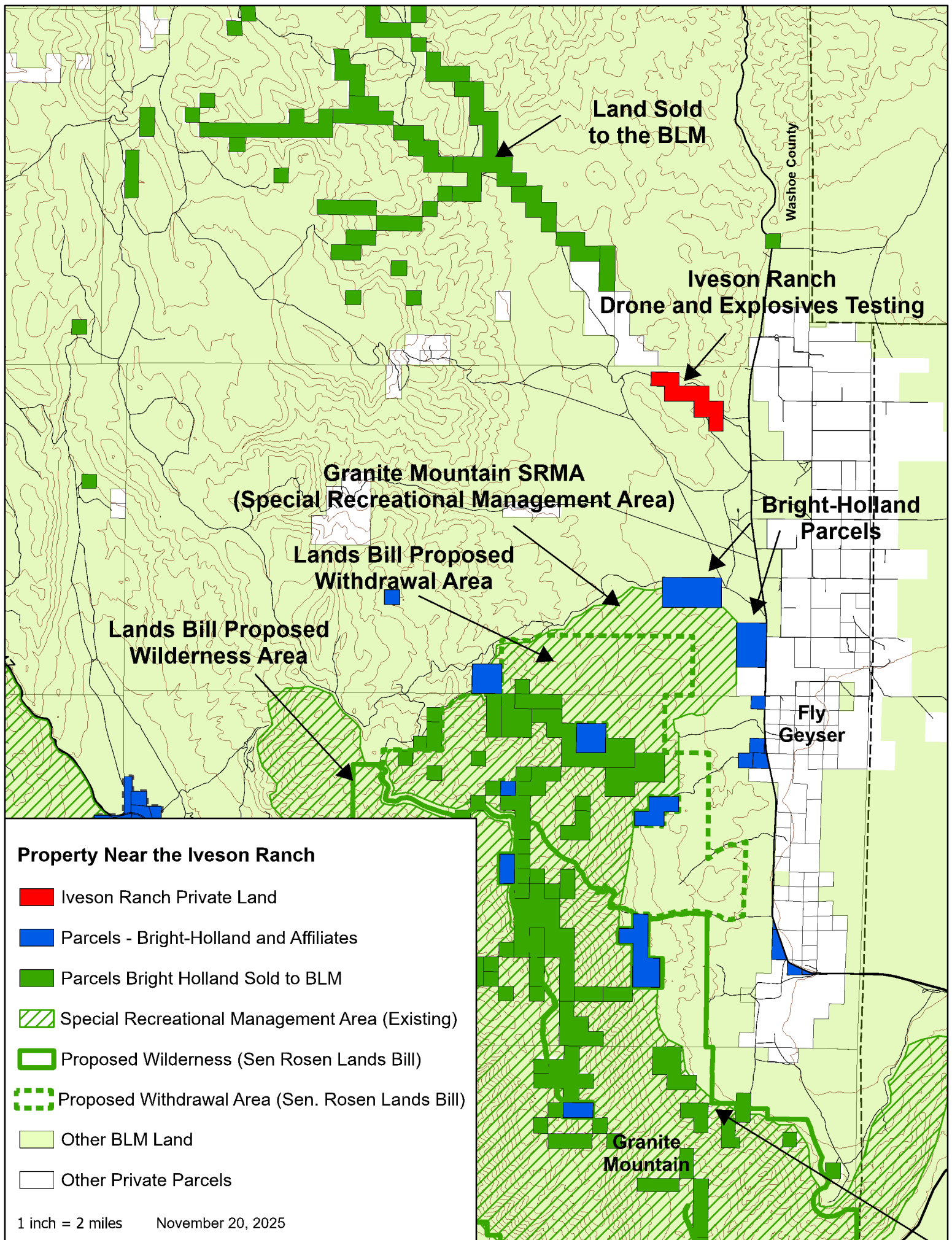

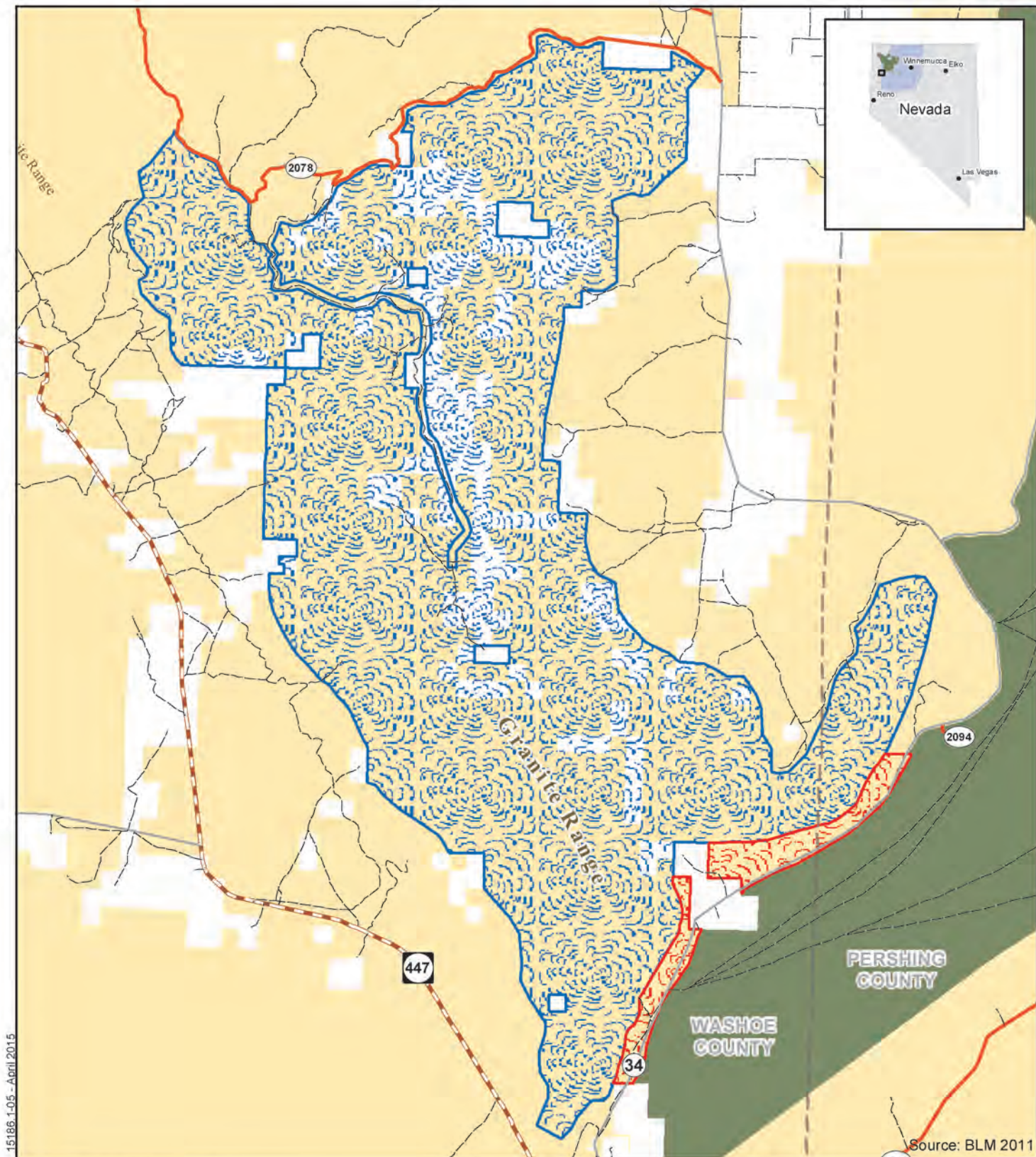

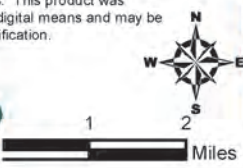

Dear Commissioners,

As a Board of Director for the Friends of Black Rock–High Rock, a Consultant for the Nevada Wildlife Federation, and a long-time resident of Washoe County, I would like to provide public comment on the Iverson Ranch Special Use Permit (SUP).

The Black Rock Desert–High Rock Canyon Emigrant Trails National Conservation Area (NCA) provides habitat and migration corridors to a diverse array of Nevada wildlife, including bighorn sheep, golden and bald eagles, over 250 species of migratory birds, and one of the largest remaining free-roaming pronghorn antelope herds in North America. Notably, the NCA houses sage-grouse lek, brood-rearing, and wintering habitats.

Considered a high-conservation-concern species, the protection of greater sage-grouse, dependent on sagebrush steppe habitat, has become a focal point in Nevada wildlife and land management, as [71% of Nevada's sagebrush ecosystem has been lost since 1998](#) and continues to decline.

A [Bureau of Land Management study](#) suggests “that effective management of the natural soundscape is critical to the conservation and protection of sage-grouse” (p.2), as disturbingly loud noises can negatively impact their mating, bonding, and foraging behaviors. The study also states that sage-grouse **do not** habituate to the impacts of noise over time.

[According to a report on Noise Recommendations by the Nevada Department of Wildlife](#), “for greater sage-grouse, noise impacts should be limited to ≤ 10 dBA (decibel noise within human hearing range) above ambient levels in breeding, nesting, and foraging habitats” (p.6). [For reference](#), the sound of a vacuum cleaner registers at 75 dBA, and explosive sounds, such as a gunshot or siren at 100 feet, register at 140 dBA.

I am concerned that the potential explosive noises created by the Proposed Explosives Test Range at Iverson Ranch will consistently create noise levels substantially higher than NDOW's recommended limits for sage-grouse habitat. I believe this will have a direct negative impact on sage-grouse populations and other wildlife that live in and migrate through the area.

I urge the Planning Commission to take these recommendations and data points into consideration when deciding how to proceed, and I ask that wildlife monitoring requirements be put in place in the SUP to safeguard the well-being and survival of our Nevada wildlife in the NCA.
