Establishing a guardianship may remove considerable rights from an individual; therefore, it should only be considered after alternatives to guardianship have been proven ineffective or are unavailable.

Alternatives to guardianship may include:

- Representatives or Substitute Payees
- Case/Care Management
- Health Care Surrogacy
- Trusts
- Durable Powers of Attorney for Finance
- Durable Powers of Attorney for Health Care
- Living Wills
- Community Advocacy Systems
- Joint Checking Accounts
- Community Agencies/Services

## Adult Guardianship

Guardianship is the legal process by which a court determines that a person is incapable of making decisions about some or all areas of life. Because of certain medical conditions, intellectual disability, dementia, mental illness, or the inability to communicate, a person may not be able to take care of his or her own finances, make medical decisions, or understand the need for assistance with the activities of daily living.

The law presumes that all adults are competent to make decisions, unless proven otherwise, regardless of whether or not they have a disability.

Ideally, someone who has an important role in an individual's life would serve as guardian. Family members are often the natural choice to act as guardian. The role of guardian comes with significant legal responsibilities.

This program is designed to provide basic information about guardianship and to assist the family guardian in meeting the needs of their loved one.

Classes are not intended to substitute for qualified legal advice. Please seek legal counsel as needed.
