












- 5.2. <u>Dispatch</u>: REMSA is the community emergency medical dispatch center for the Franchise Service Area. REMSA will be responsible for coordinating all EMS service radio traffic for patient reports to the area hospitals and will record these transactions.
 - 9.1 <u>Dispatch Personnel Training:</u> All personnel within the REMSA dispatch facility shall be trained at the emergency medical technician or paramedic level. All medical dispatch personnel shall maintain certification as Emergency Medical Dispatchers (EMD) from the National Academy of Emergency Medical Dispatchers. New dispatch personnel shall receive training during their first six (6) month of employment. REMSA shall provide documentation of compliance to the DISTRICT annually.
- 9.2 <u>Dispatch Accreditation:</u> REMSA shall maintain the National Academy of Emergency Medical Dispatchers accreditation of the Accredited Center of Excellence.

TWENTY POINTS OF ACCREDITATION

- All team members are properly credentialed
- Software & protocols are up-to-date
- Call reviews & Quality Assurance (QA) is being conducted by properly trained individuals.
- Quality Assurance (QA) & Quality Improvement (QI) systems are in place
- Independent review of calls for inter-rater reliability
- Minimum number of cases review & meet standards



TWENTY POINTS OF ACCREDITATION

- Responder education
- Co-response / Community Education
- Continuing Education
- Policies consistent to support proper use
- Formal process to review and assign emergency and non-emergency response






