We meet you where you are at

Last month 26 individuals staying at the Campus followed through with their case managers, accomplished their Housing Plan goals and successfully exited into permanent housing!

One of our participants who was living at the Nevada Cares Campus since July of 2021 informed his case manager that he had spent the past 20 years living either on the streets, in vehicles, or in shelters. By working with his Case Manager and the Reno Housing Authority – Emergency Housing Voucher (EHV) program, he was motivated to start his search for permanent housing.

His Case Manager witnessed a positive transformation of independence with this participant throughout the process of applying for assistance, completing housing applications and quickly connecting with landlords. In just one month the participant secured a two-bedroom apartment and reconnected with family. We wish him the very best on his journey.
