Dear CHILD CARE FACILITY APPLICANT:

Thank you for your interest in becoming a licensed home child care provider! A child care facility license issued by this Agency is required for care of two or more children for compensation in your personal home.

To get started, an application must be accompanied by a nonrefundable fee based upon the number of children for whom you request licensing.

Licensed Capacity Fee 2 to 6 children \$30

7 to 12 children \$60 *(requires a Special Use Permit from your local

Zoning Department)

Child care regulations permit caring for a maximum of six (6) children; however, children under three years of age that reside in the home count in that licensed capacity. Please note that there are additional ratio restrictions based on the ages of children you intend to care for.

Prior to the issuance of your license, you and each adult member of your household must complete all necessary steps of the background clearance process to obtain a Memorandum of Eligibility from the State. Upon receipt of your application and fee, we will send you a child care background clearance packet and fingerprinting instructions for each adult member of your household (18 years of age and over). We recommend starting this process as soon as you submit your application, as it can take 90-120 days to complete.

As part of your licensure, you will be required to complete 23 hours of initial training and become a member of the Nevada Registry, Nevada's child care training approval organization (www.nevadaregistry.org). Please refer to the enclosed checklist for a full list of documentation and training that will be required from you prior to your license being issued.

Washoe County Human Services Agency wants to help you become licensed and to help you safeguard the children in your area. Our staff has many years of experience in child care, and we are currently working with over 100 home care providers. We are here to assist you through the licensing process and support you in your work with children and their families.

	Child care background clearance Memorandum of Eligibility from the State of Nevada for all adult residents (18 years of age and over). Child care background clearance packet and fingerprinting instructions will be issued upon the receipt of child care application and fee. (IMPORTANT: This can take 90-120 days, please start this process as soon as possible.)
	TB test or chest x-ray on all adult residents
	Proof of Immunization for all child residents
	Proof of pet rabies vaccination(s) – dogs, cats, ferrets, etc.
	Proof of building ownership or landlord consent to provide child care on the premises
	Proof of child care insurance coverage
-	\$300,000 liability for capacity required (maximum six children)
	Current CPR Certification (minimum 2 hours) for applicant and any alternate care provider(s)
	Course in First Aid (minimum 2 hours) for applicant and any alternate care provider(s)
	Proof of completion of the following training requirements. All courses must be approved by The Nevada Registry.
	Child Abuse and Neglect course (minimum 2 hours) completion for applicant only.
	Signs of Illness: Including Blood Borne Pathogens course (minimum 2 hours) completion for applicant only.
	Sudden Infant Death Syndrome (SIDS) training (minimum 2 hours) for applicant only (if the home will be caring for children under the age of 12 months).
	Shaken Baby Syndrome (minimum 1 hour) for applicant only (if the home will be caring for children under the age of 12 months).
	Medication Administration and Allergies (minimum 2 hours) for applicant only.
	Building/Physical Premises Safety (minimum 2 hours) for applicant only.
	Emergency Preparedness (minimum 2 hours) for applicant only.
	Transportation (minimum 1 hour) for applicant only (if transportation will be provided).
	Wellness (Obesity/Nutrition/Physical Activity) (minimum 2 hours) for applicant only.
	Child Development or Guidance and Discipline (minimum 3 hours) for applicant only.
	Proof of registration with The Nevada Registry (<u>www.nevadaregistry.org</u>).

FAMILY CHILD CARE HOME CHECKLIST Care of Two to Six Children

YOU WILL NEED:	
	2A:10:BC fire extinguisher
	Smoke alarm(s) in sleeping and common areas. All smoke alarms must be interconnected.
	Outdoor fenced play area (37.5 square feet per child; decks may qualify)

<u>Mobile home</u> family child care facilities must comply with all applicable requirements for construction and safety contained in the National Mobile Home Construction and Safety Act of 1974 (42 U.S.C. SS 5401 et seq.) and state and local tie-down requirements for such facilities.

LICENSE IS ISSUED BY: Washoe County Human Services Agency

Indoor usable area (35 square feet per child)

Please remember that until your license is issued, you are restricted to care of no more than **one** child.
