2. APPROVAL OF DECEMBER 16, 2010 LEPC (Local Emergency Planning Committee) GENERAL MEMBERSHIP MEETING MINUTES

It was moved by Rob Reeder; seconded by Jim Caughron, to approve the December 16, 2011, minutes, as submitted. MOTION CARRIED.

3. TREASURER'S REPORT – Review and acceptance of Homeland Security and SERC Grants – FFY (Federal Fiscal Year) 2010 and 2011

Cathy Ludwig – Grants Administrator, drew attention to the 2011 SERC (State Emergency Response Commission) report noting that funds had been encumbered for purchases. The Planning, Training, Operations, & Equipment grant has expended \$5,634.18; and the 2011 SERC (State Emergency Response Commission) United We Stand (UWS) has expended \$3,943.00. FFY (Federal Fiscal Year) 2009 Homeland Security SPARTAN (Schools Prepared and Ready Together Across Nevada) is 78-percent expended and should be fully expended by July 2011. The Mass Fatality grant is ±98-percent expended and anticipated to close by May 2011.

It was moved by Jim Caughron, seconded by Mitch Nowicki, to accept the Treasurer's Report, as presented. MOTION CARRIED.

**4. GRANT OPPORTUNITIES** \* – Information and discussion of upcoming and/or existing LEPC (Local Emergency Planning Committee) grants.

Cathy Ludwig – Grants Administrator, noted that the application phases for 2012 SERC (State Emergency Response Commission) Training, Planning and Equipment grant as well as the UWS (United We Stand) grants were due by Monday, February 14, 2011. A Grants and Finance Subcommittee meeting will be held on Wednesday, February 23, 2011, to review, prioritize and make recommendation to the full LEPC (Local Emergency Planning Committee) General Membership. Ms. Ludwig then noted that the HMEP (Hazardous Materials Emergency Preparedness) mid-cycle grant has \$64,000.00 for training and \$84,000.00 for planning statewide. However, those amounts are subject to change.

#### 7. UPDATE OF CITIZEN CORPS \*

Kaydie Paschall noted that Citizen Corps was in the process of registering the various programs, which should be completed by the end of February (2011) so that the organization can continue to qualify for federal funding. Ms. Paschall explained that Citizen Corps participates in various exercises such as flood, wildlife and the upcoming Broken Wing exercise. Currently the organization is preparing the "Be Prepared 101" program in conjunction with Washoe County Emergency Management and the American Red Cross.

Vice-chair Munns noted that next presentation was part of an ongoing effort to provide additional information to LEPC (Local Emergency Planning Committee) membership on topics of interest and pertinent to the group.

# 8. PRESENTATION BY THE STATE EMERGENCY RESPONSE COMMISSION ON THE SERC (State Emergency Response Commission) AND LEPC (Local Emergency Planning Committee) STRUCTURE AND RELATIONSHIP \*

Karen Pabon – Executive Director SERC (State Emergency Response Commission), outlined her previous experiences in law enforcement and grants management. Ms. Pabon introduced Jim Reagan who is a member of the SERC as well as the Washoe LEPC (Local Emergency Planning Committee). Ms. Pabon then outlined the 1986 Superfund reauthorization that created the local districts to mitigate and respond to hazardous materials incidents.

Teresa Long left the meeting at 9:21 a.m.

Ms. Pabon described the use of fees collected to plan, train and purchase equipment for the response and mitigation of hazardous materials incidents. In the State of Nevada there are seventeen (17) districts consisting of each County in the State. Ms. Pabon then briefly outlined the following sections.

Ms. Pabon provided brief descriptions of Sections 304, 311, 312,313 and others (copy of the presentation on file). The SERC structure allows for not more than twenty-five (25) members with expertise in various disciplines to protect citizens from hazardous materials and WMD (Weapons of Mass Destruction). Over time the focus of the LEPC's has expanded to include other disasters such as flood and earthquake. It was pointed out that the Hazardous Materials Plan and LEPC by-laws require specific updates and public meetings, which must be held, at minimum one a quarterly basis.

Jim Reagan extended his appreciation to Ms. Pabon and other SERC staff for their work. Mr. Reagan invited those present to attend SERC meetings and noted the spectrum of SERC members from rural areas as well as Clark and Washoe County public safety and the private sector.
