#### 3. APPROVAL OF DECEMBER 17, 2015 GENERAL MEMBERSHIP AND JANUARY 14, 2016, FEBRUARY 11, 2016 GRANTS & FINANCE SUBCOMMITTEE MEETING MINUTES

Hearing no public comments Chair Cleveland asked for Board discussion or a motion.

It was moved by Jeff Whitesides, seconded by Scott Alquist, to approve the December 17, 2015, and the January 14, 2016, General Membership minutes and the February 11, 2016, Grants and Finance Subcommittee minutes, as submitted. MOTION CARRIED.

## **4. TREASURER'S REPORT** – A review, discussion and possible action to accept Revenue and Payables reports.

Cathy Ludwig – Grants Administrator, outlined the 2016 SERC grant which started July 1, 2015. A total of \$23,373.83 has been expended of the \$28,977.00 award. The 2016 SERC HMEP is on the agenda for approval today. Drawing attention to the 2014 Homeland Security Citizen Information and Warning grant, Ms. Ludwig noted that \$126,378.81 has been expended, with \$25,909.45, encumbered. It is expected that the remaining \$2,711.74 will be spent before the end of the grant The 2014 Homeland Security Continuity of Operations/Government cycle, March 31, 2016. (COOP/COG) grant has expended all of the \$75,000.00 allocation and will be closed out by March 31, 2016. The 2014 Homeland Security Statewide SPARTAN (School Safety) grant has expended \$112,373.38 of the \$112,500.00, the remaining balance of \$126.62 will be spent by March 31, 2016. The 2015 Homeland Security Continuity of Operations/Government (COOP/COG) grant has spent \$32,400.00 of the \$70,000.00 allocation, with another \$11,400.00 encumbered. The 2015 Homeland Security Statewide Recovery Initiative of \$175,000.00 has expended \$20,443.23 to date with an \$123,500.77 encumbered. The 2015 Homeland Security additional Continuity of Operations/Government (COOP/COG) grant has encumbered \$25,000.00 of the \$100,000.00 allocation; and the 2015 Homeland Security Radio Cache grant has expended \$99,231.45 of the \$99,979.45 with the remaining balance being spent as soon as the back ordered items are received. All the 2015 Homeland Security grants end on August 31, 2017.

There were no public comments.

**5. GRANT OPPORTUNITIES** – Information and discussion of upcoming and /or existing LEPC grants.

Cathy Ludwig – Grant Coordinator, noted that the SERC UWS (United We Stand) grant, that is related to terrorism will be coming out soon. The grant award will be \$25,000.00 rather than \$30,000.00 as it has in the past, Ms. Ludwig emphasized that it will be a short turn-around time and that applications must be returned as soon as possible after the grant become available.

6. GRANT APPLICATION APPROVAL - Approval to submit a 2016 State Emergency Response Commission (SERC), Hazardous Materials Emergency Planning (HMEP) Mid-Cycle grant application to the SERC, not to exceed \$30,000.00.

Chair Cleveland explained that while the two City of Sparks representatives had asked that Sparks Fire Chief Tom Garrison be allowed to vote by proxy, legal counsel has indicated that proxy voting is not allowed.

Michelle Gitmed – LEPC Grants and Finance Subcommittee Chair, outlined the recommendation to the LEPC General Membership to approve the 2016 SERC Hazardous Materials Emergency Preparedness Mid-Cycle Planning and Training application in the following prioritized order: 1) Continuing Challenge: North Lake Tahoe Fire Protection District \$1,623.50; Reno Tahoe Airport Authority \$3,247.00; Sparks Fire Department/TRIAD \$15,884.82; and Washoe County Animal Services \$3,247.00 - 2) Hazmat IQ Training \$5,950.00 for a total grant of \$29,952.32.

Hearing no public comments chair asked for board discussion or a motion

It was moved by Brian Taylor, seconded by Eric Millette, to approve the 2016 SERC Hazardous Materials Emergency Preparedness Mid-Cycle Planning and Training Application in the following prioritized order: 1) Continuing Challenge: North Lake Tahoe Fire Protection District \$1,623.50; Reno Tahoe Airport Authority \$3,247.00; Sparks Fire Department/TRIAD \$15,884.82; and Washoe County Animal Services \$3,247.00 - 2) Hazmat IQ Training \$5,950.00 for a total grant of \$29,952.32.

Chair Cleveland emphasized that failure to attend the Continuing Challenge training resulted in a loss of grant funds that could be used by other LEPC's in the state. Chair Cleveland encouraged those requesting grant funds to assure that all positions are filled.

Michelle Gitmed – LEPC Grants and Finance Subcommittee Chair, outlined the recommendation to the LEPC General Membership to approve the 2017 SERC grant Planning, Training Equipment and Operations in the following priority: 1) TRIAD - Kappler Fully Encapsulating Suits: Qty. 8 Size XL, Qty. 4 XXL - Total \$19,900.00; Reno Police Department: Tychem F Coveralls Qty. 21 and CBRN Canisters Qty. 2 - Total \$5,060.56. Within the Operations category, requesting \$2,000.00 for operations and \$2,000.00 for recording services - Total \$4,000.00. Total Grant Request - \$24,960.56.

It was moved by Bob Sack, seconded by Spencer Lewis, to approve the 2017 SERC grant *Planning, Training and Operations in the following priority:* 1) TRIAD - Kappler Fully Encapsulating Suits: Qty. 8 Size XL, Qty. 4 XXL - Total \$19,900.00; Reno Police Department: Tychem F Coveralls Qty. 21 and CBRN Canisters Qty. 2 - Total \$5,060.56. Within the Operations category, requesting \$2,000.00 for operations and \$2,000.00 for recording services - Total \$4,000.00. Total Grant Request - \$24,960.56.

Cathy Ludwig – Grants Coordinator, commented that while the intent is to always come as close to the total grant allocation as possible, in this instance the \$38.46 for Washoe County Animal Services is being disallowed due to the amount being too small and cost prohibitive to the County to administer.

Robert A. Smith – Manager Washoe County Animal Services concurred with Ms. Ludwig's assessment.

8. \*DISCUSSION REGARDING LEPC COMMITTEES – Discussion on memberships for the LEPC General Membership and the LEPC Grants & Finance Subcommittee

Chair Cleveland opened the agenda item and outlined previous discussions with Cathy Ludwig on the Grants and Finance Committee membership roster. Chair Cleveland noted that the Owner/Operator category has representatives from Truckee Meadows Water Authority and NV Energy that typically do not seek grant funding. Another concern is whether or not it is necessary to have representatives from each of the region's fire agencies. A meeting of the Executive Committee will be scheduled to further discuss and make recommendations to the General Membership.

**9. \*UPDATE ON REGIONAL EMERGENCY MANAGEMENT EVENTS** – A briefing of regional meetings, events, trainings and exercises.

Aaron Kenneston, Emergency Manager – Washoe County Emergency Management, drew attention to the Friday, February 19, 2016, exercise to practice damage assessment. Mr. Kenneston recalled a recent Animal Services horse rescue and noted the March 15, 2016, animals and disaster class. Mr. Kenneston expressed his appreciation to the Washoe County Health District for sponsoring ICS training in the coming months and encouraged LEPC Members to complete this important training so that the region can be prepared for Hazardous Material response.

# **10.** \* **UPDATE FROM THE RADIOLOGICAL TASK FORCE -** A briefing on current radiological issues within the region.

Scott Alquist, TMCC, to date we have assigned 155 RadWatches and will be assigning 7 to Sparks Police Department. Thus far the following have been distributed: 35 – Reno Fire Department; 22 - Sparks Fire Department; 21 – Airport Authority Fire Department; 17 – TMFPD; 11 – REMSA; 11 – EOC – to include EOC, Washoe County Health, FUSION Center and NLTFPD; with the additional 7 – the total will be 162. Received grant approval for Haz-Mat IQ training in the amount of \$5950.00. Haz-Mat IQ is a scenario based training provided free of charge, all we will pay is travel and per diem. This ties in with the creation of Policies and Procedures that he and Jon Bakkedahl are drafting – once the draft is complete the document will be provided to all participating agencies for their input/edits. This document is necessary for a couple of reasons – first to set up our P&P's for the region but will also be used for the table top training Haz-IQ. The LEPC must conduct an exercise and this will satisfy that requirement.

On the WIPP front: you may remember that in February 2014 there were 2 separate events that lead to the temporary closure of that facility outside Carlsbad, NM – a salt truck fire and then a radiological release due to the use of incompatible sorbents on an inbound shipment.

For those that are not familiar with WIPP, it is the Waste Isolation Pilot Plant situated outside Carlsbad, NM. They are the only licensed underground transuranic waste repository. TRU waste, is waste generated during the cold war and the Manhattan Project. This waste is made up primarily of demolition, gowns, gloves, PPE that was contaminated with low levels of radiation. They have 2 ways of handling this waste - contact handling where workers move the casks to their final location and what they refer to as remote handled waste - this is the nastier of the waste that comes in and, by its' designation, it is handled remotely and paced into storage. The storage is located 2150 feet underground in a layer of Permian Age salt which absorbs energy and grows the where it finally encases the storage casks for permanent storage. Since the events of February 2014, the facility has been under review and addressed nearly all 75 of the corrective actions identified by the accident investigation board. Currently, what TRU waste that is being shipped is being stored on a temporary basis at a facility on the Texas/NM border. WIPP anticipates reopening for business by December 2016. It is as yet unclear how this will impact Washoe County. The WIPP transportation route through Washoe County and Nevada is still approved and once back in full operation, we "may" see an uptick in shipments. However, there is no way to accurately estimate how many, if any shipments will pass through our area.

# **11.** \* **UPDATE OF CITIZEN CORPS** – A briefing on events and activities supported by the Washoe County Citizen Corps including, but not limited to, Community Emergency Response Teams (CERT).

Shirlee Rhodes - WCSO or Designee, noted that volunteers had assisted with several projects during December including Christmas on the Corridor, and the Christmas Day buffet at the Washoe County Jail. Ms. Rhodes noted that the recent academy had 30 graduates who will continue training for certification in critical and threat assessment as well as earthquake damage assessment.
