2. APPROVAL OF DECEMBER 20, 2007 GENERAL MEMBERSHIP MEETING MINUTES

3. TREASURER'S REPORT – Review and acceptance of ODP (Office of Domestic Preparedness)/Homeland Security and SERC (State Emergency Response Commission) Grants – FFY (Federal Fiscal Year) 2006, 2007 and 2008

Cathy Ludwig – Grants Administrator, provided an overview of the 2008 SERC (State Emergency Response Commission) grant noting that the HMEP (Hazardous Materials Emergency Preparedness) grant for HazMat Explo 11 had been closed. Ms. Ludwig noted that the City of Reno Communications had not yet reported on or fully expended their 2008 SERC - Planning, Training and Equipment grant and that the expenses for the 2008 - UWS (United We Stand) grant had been encumbered. Drawing attention to the FFY (Federal Fiscal Year) 2006 Homeland Security Mass Care, Evacuation and Shelter grant was being completed, final reporting and closeout would take place in the next quarter. Regarding the 2007 Homeland Security – Mass Care, Evacuation and Shelter project, as this grant has a three (3) year performance period, it is expected the grant will be fully spent in less time.

5. APPROVAL OF A 2007 HOMELAND SECURITY, CITIZEN CORPS GRANT IN THE AMOUNT OF \$56,087 AND 2007 STATE HOMELAND SECURITY PROGRAM GRANT IN THE AMOUNT OF \$35,500 TO THE WASHOE COUNTY SHERIFF'S OFFICE FOR CONSULTANT/CONTRACTOR FEES, INSTRUCTOR FEES AND OPERATIONAL COSTS FOR THE CITIZEN CORPS PROGRAM

Val Moser – WCSO (Washoe County Sheriff's Office), provided an overview of the 2007 grants totaling \$91,587.00 for consultant/contractor and instructor fees as well as operational costs for the Citizen Corps Program.

It was moved by Jim Caughron, seconded by Steve Asher, to approve the 2007 Homeland Security, Citizens Corp Grant in the amount of \$56,087.00 and 2008 State Homeland Security Program Grant in the amount of \$35,500.00 to the Washoe County Sheriff's Office. MOTION CARRIED.

6. APPROVAL OF A 2007 HOMELAND SECURITY, LAW ENFORCEMENT TERRORISM PROTECTION PROGRAM (LETPP) GRANT IN THE AMOUNT OF \$1,568,600 TO THE WASHOE COUNTY SHERIFF'S OFFICE FOR SUPPORT OF THE NORTHERN NEVADA COUNTER TERRORISM CENTER AND SILVER SHIELD PROGRAM

Val Moser – WCSO (Washoe County Sheriff's Office), summarized the grant in the amount of \$1,568,600.00 to support the Northern Nevada Counter Terrorism Center and Silver Shield Program.

It was moved by Jim Caughron, seconded by Rob Reeder, to approve the 2007 Homeland Security Law Enforcement Terrorism Protection Program (LETPP) grant in the amount of \$1,568,600.00 to the Washoe County Sheriff's Office for the Northern Nevada Counter Terrorism Center and Silver Shield program. 7. APPROVAL OF A 2004 HOMELAND SECURITY, LAW ENFORCEMENT TERRORISM PREVENTION PROGRAM (LETPP) GRANT IN THE AMOUNT OF \$20,605.30 FOR GAS MASKS AND CANISTERS FOR THE WCSO (Washoe County Sheriff's Office), SWAT TEAM AND A 2004 STATE HOMELAND SECURITY GRANT PROGRAM (HSGP) GRANT IN THE AMOUNT OF \$7,158.90 FOR TACTICAL SUITS FOR THE WCSO, SWAT TEAM AND WCSO PERSONNEL TO ATTEND THE INTERNATIONAL WIRELESS COMMUNICATION EXPO IN LAS VEGAS (NEVADA)

Val Moser – WCSO (Washoe County Sheriff's Office), outlined the \$20,605.30 grant to the Washoe County Sheriff's Office (WCSO) for gas masks and canisters as well as the \$7,158.90 Homeland Security Grant Program grant for tactical suits. A portion of the grant will be used to send WCSO personnel to the Wireless Communication Expo in Las Vegas (Nevada).

9. UPDATE ON REGIONAL EMERGENCY MANAGEMENT EVENTS *

Aaron Kenneston – Washoe County Emergency Management, drew attention to the schedule of events (copy on file) and encouraged members to participate in the Broken Wing Exercise being led by City of Sparks Emergency Manager Gary Dunn. The tabletop exercise is scheduled on April 22, 2008. Mr. Kenneston also noted the Mega Shelter conference being hosted by the region, which is a statewide effort at the Reno Sparks Convention Center.

Nathan Edwards – Deputy District Attorney, rejoined the meeting at 9:30 a.m.

10. UPDATE FROM THE YUCCA MOUNTAIN RAIL SHIPMENTS WORKING GROUP *

Scott Alquist – Truckee Meadows Community College, narrated a PowerPoint presentation (copy on file) on Yucca Mountain Rail Shipments. Mr. Alquist noted that there are five (5) proposed routes although the Schurz route has effectively been tabled. Mr. Alquist noted that each cask of spent nuclear fuel is considered a shipment even when combined with others. Mr. Alquist then outlined the number of anticipated shipments over the next fifty (50) years and explained that budget cuts will further delay the program.

Paul Donald - Washoe County District Health, summarized the recent conference in San Antonio (Texas) noting that various subgroups had been formed to discuss specific issues. Mr. Donald noted his concern about the limited number of annual meetings (one per year) and the extent and effect of budget cuts. Mr. Donald will continue to share information obtained from the various groups as it pertains to the Yucca Mountain site and the region in particular.
