4. TREASURER'S REPORT – Review and acceptance of ODP (Office of Domestic Preparedness/Homeland Security and SERC (State Emergency Response Committee) Grants – FFY (Federal Fiscal Year) 2005 & 2006.

Cathy Ludwig, Grants Administrator, provided an overview of the Treasurer's report noting that \$211.16 from Sparks Police Department and \$2,987.20 from Reno Police Department would also be reallocated for SHSP (State Homeland Security Program) grant and \$1,032.03 from the Sparks Police Department and \$366.85 from Reno Police Department would be reallocated for the LETPP (Law Enforcement Terrorism Prevention Program grant. The Community Corps program has been fully expended. Ms. Ludwig noted that 2007 SERC (State Emergency Response Commission) grant was awarded and noted that financial reports were due for the first quarter. Ms. Ludwig noted that the HazMat Explo10 grant had been somewhat less than expected and resulted in a reduction in the number of attendees.

It was moved by Stephanie McCarty, seconded by Jim Gubbels, to accept the Treasurer's Report, as presented. MOTION CARRIED.

Chair Pedersen asked that member agencies report any unexpended funds to Ms. Ludwig for reallocation as soon as possible.

Chair Pedersen drew attention to the draft modifications to the LEPC (Local Emergency Planning Committee) Bylaws and asked member to make suggested modifications. The goal is to update and submit the revised Bylaws in advance of the SERC (State Emergency Response Commission) deadline.

It was moved by member Steve Matles, seconded by Jim Gubbels, to approve the Local Emergency Planning Committee bylaws as presented. MOTION CARRIED.

7. UPDATE ON REGIONAL EMERGENCY MANAGEMENT EVENTS

Aaron Kenneston, Washoe County Emergency Manager, provided an overview of upcoming Emergency Management events, including a tabletop HazMat exercise in Goldfield (Nevada) and an Incident Unified Command Course at the EOC (Emergency Operations Center, October 24-26, 2006. It is hoped that Homeland Security will certify the course after their review to the equivalent of the ICS-300. Additionally, a tabletop on Pandemic Flu is also scheduled by the Washoe County District Health Department. Mr. Kenneston explained that staff was in the initial phase of discussion on the development of a HazMat training program.

8. POWERPOINT PRESENTATION BY GRAINGER INDUSTRIAL SUPPLY * – Introduction of company to the LEPC (Local Emergency Planning Committee) and information on the Western States Contract Alliance (WSCA).

Dave Meibert, W.W. Grainger Supplies, Western States Contract Alliance (WSCA), drew attention to brochures (copy on file) and narrated a PowerPoint presentation (copy on file) of the products that can be supplied either same day or within a short time line when needed. Mr. Meibert noted that the local facility maintains a range of flood items for the region to support local governments. Additionally, Grainger also provides training for various products. Drawing attention to list of products that can be purchased under a range of different grants, Mr. Meibert noted that additional information can be obtained at www.grainger.com/homelandsecurity. Mr. Meibert noted that each agency would have a separate invoice listing from the website showing previous purchases. Responding to Robert Cullins – University of Nevada, Reno, inquiry about product availability in the region, Mr. Meibert explained that the Packer Way facility contained about 80,000 items currently in stock with an emphasis on Homeland Security. Over the next several months that inventory will be increased to 120,000 items and within 15 minutes of an order an order can be made available for will call pickup or shipped, with larger harder to find items available within a matter of hours. Additionally, Grainger maintains a 24-hour service center to meet emergency needs.
