#### 2. Roll call

### 3. Pledge of allegiance

### 4. Public Comment

Kelly Marschall of socialent presented a summary of the RAAH continuum of Care funding. (attached in minutes)

Steve Driscoll of City of Sparks let the Board know that Commissioner Jung is no longer on the Board and Commissioner Hartung is now the alternate for the Board. Councilman Bobzien is no longer on the Board and no alternate from Reno has been appointed yet.

Elaine Wiseman gave an update. There were 2 respondents to the RFQ. Well Care had a higher score. The cities of Reno/Sparks, Washoe County and the hospitals will provide the funding for this service. Principals from Well Care gave an update on why they want the contract to provide services at the community triage center.

Commissioner Lucey made the motion to accept the update and to allow staff to move forward with drafting an interlocal agreement between the City of Reno, City of Sparks, Washoe County and the local hospitals and Well Care. The agreement will include each jurisdiction's required contribution as set forth in AB 175. The interlocal agreement will be brought before each jurisdiction for approval.

### 12. Update, discussion and possible action on OrgCode Consulting, Inc.'s operational review of the housing and homelessness system in Washoe County. Elaine Wiseman,

Manager, Housing and Neighborhood Development, City of Reno. (For Possible Action) Elaine Wiseman gave an update. OrgCode met with key stakeholders and is getting feedback from a community based survey. The study should be done on 2-15-19 and OrgCode will be at the March CHAB meeting to present their study.
