Community Homelessness Advisory Board

April 1, 2019

1. Call to order

The meeting was called to order by Chairman Dahir at 8:30 am

2. Roll call

Chairman Dahir, Councilman Lawson, Councilman Delgado, Councilwoman Jardon, Commissioner Berkbigler and Commissioner Lucey were present.

3. Pledge of allegiance *The pledge was said.*

4. Public Comment Pat Cashell gave public comment.

A pubic comment letter from Jeff Church was read into the record.

- **5. Approval of the agenda** (For Possible Action) April 1, 2019 *Councilwoman Jardon made the motion to approve the agenda. Councilman Delgado seconded the motion. The vote was unanimous for approval.*
- 6. Approval of minutes of the February 4, 2019 meeting (For Possible Action) Commissioner Berkbigler made the motion to approve the minutes. Commissioner Lucey seconded the motion. The vote was unanimous for approval.

General Business:

7. Presentation, discussion and possible action on OrgCode Consulting, Inc.'s report on the operational review of the housing and homelessness system in Washoe County. Elaine Wiseman, Manager, Housing and Neighborhood Development, City of Reno. Erin Wixsten, OrgCode consulting, Inc. (For Possible Action) David Tweedie from OrgCode presented. The PowerPoint is attached. OrgCode is working with over 200 continuum of care facilities. OrgCode presented 7 metrics for the CHAB to follow: Measure 1: Length of time persons remain homeless Measure2: The extent to which persons who exit homelessness to permanent housing destinations return to homelessness Measure 3: Number of homeless persons Measure 4: Employment and income growth for homeless persons in CoC program funded projects Measure 5: Number of persons who become homeless for the first time Measure 6: Homes prevention and housing placement of persons defined by category 3 of HUD's homes definition in Continuum of Care program funded projects Measure 7: Successful placement from street outreach and successful placement in or retention of permanent housing

Commissioner Lucey made the motion to accept the report from OrgCode, move forward with a workshop that includes transferring the responsibility of the CAC to Washoe County, within the next 18-24 months create an RFQ for transferring the service to NNAMHS and creating a master plan of

action. The action plan needs to incorporate safety, housing first and healthcare issues. Commissioner Berkbigler seconded the motion. The vote was unanimous for approval.

8. Update, discussion, and possible action on short term safety improvements for the CAC. Sabra Newby, Reno City Manager; John Slaughter, Washoe County Manager and Neil Krutz, Sparks City Manager. (For Possible Action)

The 3 Managers asked for the discretion to solve the issues that are occurring on the CAC campus. Staff was asked to describe the most recent 3 incidences. The incidents seem to occur around the food service times and it's happening at the outside food service. Pat Cashell asked for the outside feeding to stop as soon as possible which would help alleviate some of the problems that occur during feeding hours.

Commissioner Lucey made the motion to allow the 3 managers to make changes immediately as to policy and security at the CAC, get rid of outside feeding of homeless on the CAC campus and complete a threat assessment of the campus. Councilwoman Jardon seconded the motion. The vote was unanimous for approval.
