My name is Scott Finley.

I am a resident of Washoe County and have a military background in the Financial Management & Comptroller career field of the United States Air Force.

Why does Washoe County not respect privacy? Why does it not understand what consent means?

The Audit Committee needs to state an official privacy policy and recognize that all personally identifiable information about a Washoe County resident, other than their first and last name, is private information. In addition, for transparency purposes, this committee needs to state a due diligence policy and by default upload the audio recordings of its meeting within 30 days.

At the end of the last Board of County Commissioners meeting, it was brought to my attention that individuals on the Audit Committee are responsible for the upload of public comments at prior meetings containing personally identifiable information. I sought to verify this fact, yet the main Washoe 311 page for submitting a public records request has been down for at least 3 weeks. Last Friday, I found out that I could submit a public records request through the Clerk's Office, which as you can see I did Friday night. If transparency were a defining facet of this committee, then it would have performed basic due diligence by automatically uploading the audio recordings of each meeting when possible without someone like me having to submit a public records request.

For whatever reason, the main Washoe 311 page that I have always used for submitting a public records request appears to have been torpedoed and it makes me wonder how many other Washoe County residents are encountering this problem without a work around. Washoe 311 was launched in May of 2018 and is considered software-as-a-service, a cloud based software delivery model that allows end users to access software applications over the Internet. This service is operated by an entity called Granicus, headquartered in Denver, Colorado.

Instead of Granicus rushing the implementation of the SpeakUp platform in Washoe County, it should focus on fixing the problems encountered with Washoe 311. Since these problems occur at the most inopportune of times, maybe we should consider completely scrapping Washoe 311 and come up with our own county-based solutions that are not dependent on a cloud-based software company who influences or is influenced by tech giants like Facebook?

For these reasons, the Audit Committee needs to state an official privacy policy and a due diligence policy.

6. The first/last name of the individual that typed up the minutes for the June 9th and June 22nd meetings, and a copy of their certification to

operate as a court reporter.

7. The date/time and first/last name of the county employees (or board members) responsible for uploading the public comment minutes under the "Additional Meeting Resources" for the June 22nd meeting.

Pursuant NRS 241.035(4), except as otherwise provided in subsection 8, a public body shall, for each of its meetings, whether public or closed, record the meeting on audiotape or another means of sound reproduction or cause the meeting to be transcribed by a court reporter who is certified pursuant to chapter 656 of NRS. If a public body makes an audio recording of a meeting or causes a meeting to be transcribed pursuant to this subsection, the audio recording or transcript:

- (a) Must be retained by the public body for at least 3 years after the adjournment of the meeting at which it was recorded or transcribed;
- (b) Except as otherwise provided in this section, is a public record and must be made available for inspection by the public during the time the recording or transcript is retained.

This request is for an electronic copy or extract of data in a standard, machine reachable data format (such as delimited or fixed text, Excel or other spreadsheet, MS-Access, or dBase) that can be readily imported by database software. A pdf (Adobe Acrobat) file will be accepted format for a response to this request. A MP3, MP4, WEBM, MOV, or WMV (audio/video) file will be accepted format for a response to this request.
