Forum Restrictions and Orderly Conduct of Business: The Regional Public Safety Training Center Managers conduct the business of the Regional Public Safety Training Center during its meetings. The presiding officer may order the removal of any person whose statement or other conduct disrupts the orderly, efficient or safe conduct of the meeting. Warnings against disruptive comments or behavior may or may not be given prior to removal. The viewpoint of a speaker will not be restricted, but reasonable restrictions may be imposed upon the time, place, and manner of speech. Irrelevant and unduly repetitious statements and personal attacks which antagonize or incite others are examples of speech that may be reasonably limited.

Public Comment: Public comments are welcomed during the public Comment periods of all matters, whether listed on the agenda or not, as are limited to three minutes per person. Persons are invited to submit comments in writing on the agenda items and/or attend and make comment on that item at the meeting. Persons may not allocate unused time to other speakers. Members of the public wishing to have their complete

A., 2nd Floor, Reno, Nevada) Marilyn Kramer, Agenda Coordinator, (775) 328-2002 and on Washoe County's website <u>www.washoecounty.us/bcc/board_committees/</u>. <u>Responses to Public Comment:</u> The Board can deliberate or take action only if a matter has been listed on an agenda property posted prior to the meeting. During the public comment period, speakers may address matters listed or not listed on the published agenda. The Open Meeting Law does not expressly prohibit responses to public comments by the Board. However, responses from the Board to unlisted public comment topics could become deliberation on a matter without notice to the public. On the advice of legal counsel and to ensure the public has notice of all matters the Board will consider, the Board may choose not to respond to public comments, except to correct factual inaccuracies, ask for County staff action or to ask that a matter be listed on a future agenda. The Board may do this either during the public comment item or during the following item: "Topics for Future Agenda".
