Recent accomplishments

- As of April 2017, 680 permits or licenses taken regionally in Accela via online applications since 10/31. 18 are Washoe's number and only in licensing have we taken online **permits** thus far. Payments taken online total \$6,978.62 to date and cross multiple departments in Health, Building, Licensing being the main online payments received thus far. We expect this number to grow with the press release of ACA on 2/27/17. Regionally we have taken over 23,000 permits in Accela back office system since 10/31. 3/7 Oversight meeting asked for a percentage of online applications we were expecting and the goal was for 30% initially and growing annually to help reduce counter traffic and improve efficiencies for citizens.

- **Mental Health Program for Seniors:** County has taken over the MOST team and opened the TADS program.



Recent Accomplishments
