
Dear Doug Doolittle,

RE: The River School Farm and surrounding county park lands

Dear Mr. Doolittle;

I came to Reno in 1969 when my father, Ed Kleiner Sr, joined the faculty at UNR. I recall as a student at Reno High School the day a truck load of strawberries floated through town when a truck driver chose the wrong bridge while coming into Reno from the west. The area where the River Fork Ranch now sits looked much like the current perimeter of the Truckee Meadows, disturbed lands, weeds, etc.. We've come a long way since then with park development and riparian corridor improvements that are all but unanimously appreciated by all. I am currently watching all the wonderful changes to the Truckee Meadows from my farm in Gardnerville.

Over the years, Tom Stille has played such an influential role in putting a responsible and beautiful footprint onto the urban development in Reno. Most importantly, his role in moving our landscapes towards the native species and the drought tolerance that is so important today.

Evidently, he has issues with neighbors across the river. Tom is well networked into the social fabric of Reno in such diverse and positive ways and his notoriety has brought him a following at all levels of our region; indeed he is famous with the local landscaping industry. His improvement to the public property adjacent to his private parcel should be considered an asset to all who frequent the river corridor for recreation and enjoyment of the open space preserved. The frequent use of this property for various positive activities can only attest to the true value of this asset.

I suspect that the issues related to light and noise can be mitigated without reverting the space back to a pile of weeds and rocks that it once was. It would be hard to stretch the costs to outweigh the benefits of the current use of this land. Last, in a fiscal sense the county should be thrilled to have such a beneficiary expending private sweat equity for the benefit of the public; the county has enough challenges with budgeting all the work they currently have for the growing park lands in the Truckee Meadows.

I request that you please find a happy medium to allow for the coexistence of this lovely part of town with the slowly expanding urban growth that surrounds the River Farm. Sincerely;
