OUTDOOR COMMUNITY EVENT LICENSE GENERAL PROCEDURES

Definition:

"Outdoor community event" means an assembly of more than 100 and less than 1,000 persons on any one day of the event gathered together for any purpose, at any location, other than a permanent building or permanent installation that has been constructed for and will accommodate the number of persons gathered therein.

1. **APPLICATION.** Complete the form in ink. This application is for events with attendance over 100 and less than 1,000 persons on any one day the event. There is a \$50.00 nonrefundable application fee. Applications will be returned if the application fee is not included. Three paper copies of the application and one electronic pdf file (memory stick or DVD) must be turned in at least **90 days** before the event. The application must include all required forms.



- 2. APPLICATION DEADLINE. All applications must be submitted at least 90 days in advance of the event.
- 3. **LICENSING/PERMIT REQUIREMENTS.** An outdoor community event license is required on any public or private lands in the unincorporated area of Washoe County except for lands managed by the Washoe County Parks Department and state, trust, tribal, and federal lands. All events must meet land use/regulatory zone requirements before the license will be issued. For information on land use/regulatory zone requirements, call (775) 328-6100 with the parcel number(s) of the event. There are special application processes, depending on the size of the event:
 - a. Events with between 100 and 299 people on any one day of the event. These events require an outdoor community event license only. The Director of the Planning and Development Division shall approve, approve with conditions, or deny the license.
 - b. Events with between 300 and 999 people on any one day of the event. These events shall obtain both an outdoor community event license and an administrative permit. This application shall suffice for the outdoor community event license application and the administrative permit application. No additional fees are required for filing the administrative permit application. The Board of Adjustment shall approve, approve with conditions, or deny the license and permit.







This Equipment Lease Agreement ("Agreement"), dated as of 4/2/2021 is by and between Under Canvas® Inc., a Delaware corporation, having its principal place of business at 1172 Happy Lane, Belgrade, MT 59714 ("Under Canvas"), and EO Alchemy ("Client," and together with Under Canvas, the "Parties," and each, a "Party").

WHEREAS, Under Canvas is in the business of leasing premier glamping tents, equipment, supplies and accessories; and

WHEREAS, Client desires to lease from Under Canvas, and Under Canvas desires to lease to Client, the equipment and supplies for Client's event(s) as more specifically described in this Agreement.

NOW, THEREFORE, in consideration of the mutual covenants, terms and conditions set forth herein, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

1. Definitions:

- 1.1 **"Event"** means the event for which Client will use the Equipment, as set forth on the Order Form.
- 1.2 "Order Form" the rental order executed by the Parties for the Equipment.
- 1.3 "Rental Charge" is the amount payable by Client to Under Canvas for the lease, as set forth in the Order Form.
- 1.4 "Rental Period" is the period between completing the set-up of the Equipment and beginning the dismantling, as set forth in the Order Form.
- **"Site"** shall mean the property for delivery of the Equipment, as set forth in the Order Form.
- 2. Lease. Under Canvas agrees to lease to Client, and Client agrees to lease from Under Canvas, the equipment described more fully in applicable Order Form (the "Equipment").
- 3. Operation of Equipment. Client shall not remove the Equipment from Client's address specified on the applicable Order Form without prior written approval of Under Canvas. Client shall allow Under Canvas to enter Client's premises at all reasonable times to locate and inspect

the state and condition of the Equipment. Client shall follow Under Canvas' instructions regarding the use and maintenance of the Equipment.

Under Canvas Obligations:

- 4.1 Under Canvas will use commercially reasonable efforts to deliver the agreed Equipment and Third Party Products on-time and in good working order as set forth in the Order Form. Under Canvas will set-up and take-down the Equipment as described in the Order Form.
- 4.2 Under Canvas will make every effort to complete the erection of the Equipment on or before the agreed date, provided that Client has complied with the undertakings set forth herein and in the applicable Order Form. If the Equipment is not erected because of delays due to weather or other circumstances beyond its reasonable control, Under Canvas shall not be liable to compensate Client.
- 4.3 Under Canvas will use commercially reasonable efforts to maintain and check the Equipment regularly during the applicable Rental Period. Under Canvas will take reasonable care to avoid damage to Clients' own equipment and property but cannot be responsible for any loss suffered by Client in respect thereof.

5. Client Obligations:

- 5.1 Upon execution of this Agreement, Client shall provide Under Canvas a detailed map or plan of the location, including the specific location(s) of any and all tents or other Equipment satisfying the requirements below.
- Unless agreed otherwise in the applicable Order Form, the Rental Charge, outlined above, is based on the assumption that Client provides a firm, level, and sufficiently large location of grass (or some other material not impervious to stakes and able to absorb rainwater, as acceptable by Under Canvas in its sole discretion) on the Site, and it is served by a firm access road adjacent to the Site with adequate parking for commercial vehicles that is free from standing water, trees and overhead obstructions. If Client fails to comply with the foregoing or if Client wishes Under Canvas to erect the Equipment in a different position or location on the Site to the one indicated by Client to Under Canvas at the time of booking, and the costs to Under Canvas are subsequently increased, Under Canvas may increase the price of the Invoice accordingly.
- 5.3 Client shall inspect all Equipment before use and should notify Under Canvas of any miscounts, incorrect deliveries or unacceptable Equipment before use.
- Client shall provide Under Canvas with either a plan showing the position in which the Equipment is to be erected and all underground services and any apparent obstacles, or to make available a representative on the Site for that purpose. In the absence of both, Under Canvas shall erect the Equipment where it thinks fit, which shall be deemed satisfactorily completed with respect to this Agreement, and Under Canvas shall not be responsible for damage to

underground services or any other damages caused by Client's failure to comply with this paragraph.

- 5.5 Client agrees not to light, or allow to be lit, any fire, candle or other naked flame other than use of the woodstoves within or close proximity to the Equipment without the prior written consent of Under Canvas.
- 5.6 Client shall not tamper with the structure or any part of the Equipment and, in particular, not to affix or suspend from the Equipment any item whatsoever without Under Canvas' prior written consent.
- 5.7 Client shall use the Equipment only for the stated and intended purposes and shall not allow any illegal or unlawful activity to occur on the Site at any time the Equipment is located thereon. Client shall assume and be solely responsible for all loss or damage to property, material, or equipment belonging to any Party that Client causes, and to any harm or damage incurred or suffered by any person on the Site. Client is encouraged to obtain all appropriate equipment, material, or other liability insurance(s) against such risk of loss.
- 5.8 Client shall inspect the Equipment upon completion of the set-up period as outlined above. Unless Client notifies Under Canvas in writing prior to the commencement of the Event, specifying any defect in or other proper objection to the Equipment, Client agrees that it shall be conclusively presumed that Client has fully inspected and acknowledged that the Equipment is in full compliance with the terms of this Agreement, is in good condition and repair, and that Client is satisfied with and has fully accepted the Equipment in such condition.
- 5.9 Client shall provide Under Canvas will full and complete access to the Equipment for the purposes of inspecting the Equipment and fulfilling Under Canvas' obligations hereunder.
- 5.10 Client shall not delay or hinder Under Canvas from completing set up or take-down in a timely manner. Should a delay be caused by Client that delays Under Canvas from completing its task, all additional expenses incurred will be charged directly to Client.
- 6. Deposit and Damage Deposit. A non-refundable 50% deposit ("Deposit") is required to confirm the Order Form payable upon the execution of the applicable Order Form, and the remainder of the applicable Invoice is payable 30 days prior to the first day of the Event. A separate refundable "Damage Deposit" is intended to cover Under Canvas against loss of or damage to all rented Equipment whatsoever the cause. The Damage Deposit will be returned to Client, less any damages to the tents and furnishings or Equipment, within 14 days after takedown has been completed. Please note charges incurred due to direct bank deposits will be deducted from the Damage Deposit.
- 7. Rent. In consideration of Client's right to possess and use the Equipment during the Term (as defined in Section 13), Client shall pay the Rental Charge in advance, 30 days prior to the Event, with set-off only for the Damage Deposit, in US dollars, by direct bank transfer (bank details: Rocky Mountain Bank, Under Canvas® Inc., Account Number 9100324230, Routing

Number 092901214) or by check (made payable to Under Canvas® Inc. at 1172 Happy Lane, Belgrade, MT 59714. Except with regards to the Damage Deposit, which may be returned to Client only as outlined herein, all such payment amounts shall immediately become non-refundable.

- 7.1 Under Canvas reserves the right not to provide the Equipment should full payment not be timely received as set forth herein. Client shall pay interest on all late payments at the lesser of the rate of 1.5% per month and the highest rate permissible under applicable law, calculated daily and compounded monthly. Client shall reimburse Under Canvas for all costs incurred in collecting any late payments, including, without limitation, attorneys' fees. Payment of any late charge does not excuse Client of any default under this Agreement.
- 7.2 All taxes, penalties, or fees due to any regulatory bodies will be charged as an addition to the Demand Deposit and Invoiced amounts, and are payable (in advance) by Client.
- 7.3 If by the termination or expiration of the Term, Client does not return the Equipment to Under Canvas in the condition and on the terms and conditions of Section 10, Client shall continue to comply with all the terms and conditions of this Agreement, including the obligation to pay two-hundred percent (200%) of the prorated daily Rental Charge for each day from the termination or expiration of the Term until the date on which Client returns such Equipment to Under Canvas in the manner required under Section 10 ("Holdover Rent"). It is imperative that Client return the Equipment as agreed and on-time. Client shall not construe anything contained in this Section, including Client's payment of Holdover Rent, as Under Canvas' (a) waiver of Client's failure to perform any obligation under this Agreement; or (b) assent to any renewal of this Agreement.
- 8. Limited Warranty. Under Canvas shall replace the Equipment with identical or similar Equipment if the Equipment fails to operate in accordance with the manufacturer's specifications and operation instructions. Such replacement shall be made as soon as practicable after Client returns, or alerts Under Canvas of, the non-conforming Equipment. Client shall return all non-conforming Equipment at its expense and risk of loss to Under Canvas to the destination specified by Under Canvas. Products manufactured by a third party ("Third-Party Product") may constitute, contain, be contained in, incorporated into, attached to, or packaged together with, the Equipment. Third-Party Products are not covered by the above limited warranty.

The limited warranty above does not apply where the Equipment has been subjected to abuse, misuse, neglect, negligence, accident, improper testing, improper installation, improper storage, improper handling, abnormal physical stress, abnormal environmental conditions, or use contrary to any instructions issued by Under Canvas, or used with any Third-Party Product, hardware, software, or product that has not been previously approved in writing by Under Canvas.

Client shall bear all risk of loss, damage, destruction, theft, and condemnation to or of the Equipment from any cause whatsoever ("Loss") until the Equipment has been returned to Under Canvas to the destination specified in Section. The Rental Charge does not include making good any repairs to the Site except to the extent caused by the negligence of Under Canvas' servants, agents or contractors.
- Compliance with Law. Client shall (a) comply with all applicable laws, regulations, and 10.3 ordinances and (b) maintain in effect all the licenses, permissions, authorizations, consents, and permits that it needs to carry out its obligations under this Agreement. Additionally, Client shall obtain any and all permits of any kind or nature from any authorities, and to make application where necessary to all: planning and border authorities, zoning laws or commissions; brokers; blue stakes or other similar organizations for any and all underground systems or structures; district surveyor or similar agencies; police, fire, or other emergency response agency; forest service, any and all other similar authority or organization as required for the Event, the site and Equipment-related services described herein (the "Licenses"). Any costs incurred in delays or modifications in the work arising from the absence or misrepresentation of all Licenses shall be payable to Under Canvas by Client. Client shall obtain and completely and fully satisfy all requirements under the Licenses and notify Under Canvas of all such obligations or requirements with which it must comply, in writing, at least 28 days prior to set-up. Should Under Canvas for any reason be unable to comply with these requirements, then it shall notify Client and the Agreement and/or applicable Order Form(s) shall be deemed to have been cancelled by Client.
- 11. Indemnification. Client shall indemnify, defend, and hold harmless Under Canvas and its officers, directors, employees, agents, affiliates, successors, and permitted assigns

(collectively, "Indemnified Party") against any and all losses, damages, liabilities, deficiencies, claims, actions, judgments, settlements, interest, awards, penalties, fines, costs, or, expenses of whatever kind, including attorneys' fees, fees and the costs of enforcing any right to indemnification under this Agreement, and the cost of pursuing any insurance providers, incurred by Indemnified Party, relating to any claim of a third party arising out of or occurring in connection with the Equipment or Client's negligence, willful misconduct, death, bodily injury, property damage, or breach of this Agreement, except to the extent due to gross negligence by Under Canvas. Client shall not enter into any settlement without Under Canvas' or Indemnified Party's prior written consent.

- 12. Insurance. Under Canvas strongly recommends that Clients obtain insurance for its possible damage to the Equipment.
- Term and Termination. The term of this Agreement commences on the date of this 13. Agreement and continues until terminated as provided under this Agreement (the "Term"). In addition to any remedies that may be provided in this Agreement, either Party may terminate this Agreement and/or the applicable Order Form(s) with immediate effect upon notice to the other Party, if the other Party: (i) fails to pay any amount when due under this Agreement or the applicable Order Form(s) and such failure continues for 30 days after the other Party's receipt of notice of nonpayment; (ii) has not otherwise performed or complied with any of the terms of this Agreement, in whole or in part; or (iii) becomes insolvent, files a petition for bankruptcy, or commences or has commenced against it proceedings relating to bankruptcy, receivership, reorganization, or assignment for the benefit of creditors. If Client is in default of any of the terms and conditions of this Agreement, Under Canvas, and its agents, at Client's risk, cost, and expense may at any time enter Client's premises where the Equipment is stored or used and recover the Equipment. Either Party may cancel this Agreement and/or any Order Form(s) upon 30 days' written notice to the other Party. Client acknowledges that if Client cancels the Agreement or the applicable Order Form at any time prior to 30 days before the start of the set-up of the Event, then the Deposit shall be non-refundable and shall be retained by Under Canvas. If Client terminates the Agreement and/or any Order Form(s) at any time following 30 days before the start of the set-up of the Event, then the entire Invoice and Rental Charges for the applicable Order Form(s) shall be non-refundable. Any and all unpaid amounts otherwise due and owing shall continue to be due and owing by Client upon termination of this Agreement and/or any Order Form(s).9/10
- 14. Confidential Information. All non-public, confidential, or proprietary information of Under Canvas, including, but not limited to, specifications, samples, patterns, designs, plans, drawings, documents, data, business operations, customer lists, pricing, discounts, or rebates, disclosed by Under Canvas to Client, whether disclosed orally or disclosed or accessed in written, electronic, or other form or media, and whether or not marked, designated, or otherwise identified as "confidential," in connection with this Agreement is confidential, solely for the use of performing this Agreement and may not be disclosed or copied unless authorized by Under Canvas in writing. Upon Under Canvas' request, Client shall promptly return all documents and other materials received from Under Canvas. Under Canvas shall be entitled to injunctive relief

for any violation of this Section. This Section shall not apply to information that is: (a) in the public domain; (b) known to Client at the time of disclosure; or (c) rightfully obtained by Client on a non-confidential basis from a third party.

- 15. Entire Agreement. This Agreement, including and together with any related exhibits, schedules, attachments, Order Forms, and appendices, constitutes the sole and entire agreement of the Parties with respect to the subject matter contained herein, and supersedes all prior and contemporaneous understandings, agreements, representations, and warranties, both written and oral, regarding such subject matter.
- 16. Survival. Subject to the limitations and other provisions of this Agreement: (a) the representations and warranties of the Parties contained herein shall survive the termination of this Agreement; and (b) Sections 1, 5, 7 and 10 through 29 of this Agreement, as well as any other provision that, in order to give proper effect to its intent, should survive such expiration or termination, shall survive the expiration or earlier termination of this Agreement.
- Notices. All notices, requests, consents, claims, demands, waivers, summons, and 17. other legal process, and other similar types of communications hereunder must be in writing and addressed to the relevant Party at the address set forth on the first page of this Agreement (or to such other address that may be designated by the receiving Party from time to time in return-receipt via Section 17), or accordance with this Hannah.brennan@undercanvas.com. All non-emailed notices must be delivered by personal delivery, nationally recognized overnight courier (with all fees pre-paid), or certified or registered mail (in each case, return receipt requested, postage prepaid). A notice is effective only (i) upon receipt by the receiving Party, or in the case of email, upon the time/date of the automated return receipt email, and (ii) if the Party giving the notice has complied with the requirements of this Section 17.

- 24. Choice of Law and Choice of Forum. This Agreement and all matters arising out of or relating to this Agreement are governed by, and construed in accordance with, the laws of the State of Delaware, without regard to the conflict of laws provisions of such State. Subject to Article 25, any legal suit, action, or proceeding arising out of or relating to this Agreement must be instituted in the federal courts of the United States of America or the courts of the State of Colorado, and each Party irrevocably submits to the exclusive jurisdiction of such courts in any such suit, action, or proceeding. The parties expressly agree that the United Nations Convention on Contracts for the International Sale of Goods shall not apply to this Agreement.
- 25. Arbitration. Any and all claims, controversies and disputes between the parties hereto that arise out of or relate to this Agreement, or to the breach, termination or invalidity thereof, shall be exclusively and finally settled by arbitration before the American Arbitration Association and in accordance with the Commercial Arbitration Rules of the American Arbitration Association. There shall be one arbitrator who shall be appointed by the American Arbitration Association. The location of the arbitration shall be Denver, Colorado, unless otherwise agreed by the parties hereto in writing. The arbitrator shall be solely bound and governed by the laws of the State of Delaware, without regard to the choice or conflicts of laws rules thereof and without regard to the United Nations Convention on Contracts for the International Sale of Goods. 






Project Description: This year's countrywide conference, Alchemy, for The Entrepreneur's Organization is being held at the Hyatt Regency Hotel in Incline Village, Nevada. The even runs from October 11-14, 2021, and will host 400 entrepreneurs and their guests, for a total of around 500 people.

We seek permits to put up two tents for the duration of this conference. Both will go up on Monday, October 11, 2021, and come down on Friday, October 15, 2021. They are owned by and will be set up and properly secured (using sandbags and no guy lines) by Under Canvas on the Cottage Green in the Lakeside area at the Hyatt.

The smaller tent, the Safari Tent, is $12' \times 16'$. It will be set up on a $24' \times 32'$ stage and serve as a sort of "green room" for speakers prepping to go out on stage and address conference attendees. It will hold a few chairs for queued presenters and a handful of personal effects while presenters are out on stage. It will not have electricity, gas, or anything else of that nature and both ends will remain propped open for the duration of the conference. It will be securely planted using the sandbags of the appropriate calculated weight, determined by Under Canvas.

The larger tent, the Marqui Tent, is $62' \times 29'$. It will be set on grass and hold 9 sponsor booths (each of which are $4.5' \times 2'$) and two clusters of three couches each. It will have electricity provided by the Hyatt, set up by the AV team. The entire long side facing the rest of the Cottage Green will be set open for the duration of the event. It will be securely planted using sandbags of the appropriate weight, as calculated by Under Canvas.

Access to restrooms and port-o-potties can be found on each side of the Cottage Green. Emergency vehicle access is easily reached just behind both sides of the ring of cottages surrounding the Green. A large water valve is also located on the North side of the Cottage Green. Adequate signage ("Exit", "No Smoking", and "Occupant Load" for each tent) as well as fire extinguishers will be prominently posted.

In between the Marqui Tent and the stage containing the Safari Tent will be 500 folding chairs set in the grass and 12 picnic tables. Tents will not be occupied (except by set up and strike crews) on Monday, October 11 and Friday, October 15, but will have conference attendees engaged in outdoor general sessions on Tuesday through Thursday, October 12-14, 2021.

[ASCE 7 - Chapter 31] Wind Tunnel Procedure

31.1 SCOPE

The Wind Tunnel Procedure shall be used where required by Sections 27.1.3, 28.1.3, and 29.1.3. The Wind Tunnel Procedure shall be permitted for any building or other structure in lieu of the design procedures specified in Chapter 27 (main wind force resisting system [MWFRS] for buildings of all heights and simple diaphragm buildings with h ≤ 160 ft (48.8 m)). Chapter 28 (MWFRS of low-rise buildings and simple diaphragm, low-rise buildings), Chapter 29 (MWFRS for all other structures), and Chapter 30 (components and cladding [C&C] for all building types and other structures).

User Note: Chapter 31 may always be used for determining wind pressures for the MWFRS and/or for C&C of any building or other structure. This method is considered to produce the most accurate wind pressures of any method specified in this standard.

31.4 LOAD EFFECTS

31.4.1 Mean Recurrence Intervals of Load Effects.

The load effect required for strength design shall be determined for the

same mean recurrence interval as for the analytical method by using a rational analysis method, defined in the recognized literature, for combining the directional wind tunnel data with the directional meteorological data or probabilistic models based thereon. The load effect required for allowable stress design shall be equal to the load effect required for strength design divided by 1.6. For buildings or other structures that are sensitive to possible variations in the values of the dynamic parameters, sensitivity studies shall be required to provide a rational basis for design recommendations.

- 31.4.2 Limitations on Wind Speeds. The wind speeds and probabilistic estimates based thereon shall be subject to the limitations described in Section 26.5.3.
- 31.4.3 Wind Directionality. The directional wind climate based on recorded or simulated directional wind speed data shall be considered in determining wind loads and the data shall be presented as part of the wind tunnel report submitted to the Authority Having Jurisdiction. The method for combining wind tunnel model data with information on wind speed and direction at the project site shall also be clearly stated in the Wind Tunnel Report. Variation in the wind direction, based upon uncertainty in the wind climate data, shall be considered when determining the wind loading, and the design wind loads shall be based on the largest values that result from this uncertainty. Consideration of uncertainty in the wind direction is not required in the determination of serviceability related wind effects.
- 31.4.4 Limitations on Loads. Loads for the MWFRS determined by wind tunnel testing shall be limited such that the overall principal loads in the x and y directions are not less than 80% of those that would be obtained from Part 1 of Chapter 27 or Part 1 of Chapter 28 for buildings or Chapter 29 for other structures. The overall principal load for buildings shall be based on the overturning moment for flexible buildings and the base shear for other buildings. The overall principal load for other structures shall be based on the overturning moment for flexible structures and the base shear for other structures. Pressures for C&C determined by wind tunnel testing shall be limited to not less than 80% of those calculated for Zone 4 for walls and Zone 1 for roofs using the procedure of Chapter 30. These zones refer to those shown in Figs. 30.3-1 30.3-2A-C. 30.3-3, 30.3-4, 30.3-5A-B, 30.3-6, 30.3-7, and 30.5-1


The limiting values of 80% may be reduced to 50% for the MWFRS and 65% for C&C if either of the following conditions applies

- 1 There were no specific influential buildings or objects within the detailed proximity model
- 2. Loads and pressures from supplemental tests for all significant wind directions in which specificinfluential buildings or objects are replaced by the roughness representative of the adjacent roughness condition, but not rougher than Exposure B. are included in the test results.







Load capacity is not a simple function of "soil class" (the general type of soil, listed at the lower left of these strength charts) but also of real-time moisture content, compaction, root penetration, installation method, pullout load angle, and other factors unique to the installation's time and place.

The only method of accurately predicting the load capacity of an anchor at a specific site is by an onsite <u>proof test</u> of the anchor under local conditions, installed and loaded in the same manner as the intended application.
