No other files – such as photographs or documents – should be included. Documents and photographs must be 25 filed separately by using the Court's *List of Proposed Exhibits* form. Parties may not submit more than 10 audio/video files unless the judge approves a 26 motion to enlarge this number. 27 Each audio or video file on the flash drive must be **named exactly** as it appears on the Audio Video Exhibit List below. The first line is for demonstration purposes only.
