The Daybreak Program offers group care during the day in a safe, comfortable environment, comfortable for disabled persons.

This unique program provides a wide spectrum of services under the supervision of a qualified nursing staff.

Participants may attend the program from 7:30am to 5:30 pm one or more days a week, Monday through Friday. Note the program is closed for Federal Holidays.

Respite for family - Daybreak provides relief for the caregiving family, allowing them to continue with their personal activities and employment.

Overcoming Isolation - The group setting aids participants in overcoming the isolation which often occurs with illness. It also aids in maintaining physical health and emotional well-being.
