When the LVMPD investigation of the Route 91 Harvest Festival shooting on 1 October 2017 deleted one of the weapons (pellet gun) from the manifest of arms sequestered by the FBI, and currently under a court directive on deciding whether or not to allow those weapons to be destroyed, it made a terrible blunder. It drew attention to the lack of accountability by those responsible for taking the inventory, it ignored the testimony given by security officers and police who breached the 32nd floor and it called into question why no where in the investigation was there any mention of a shooting incident that took place in Reno one year earlier involving the same type of weapon, and which has never been resolved.


