Abby stated Home Delivered Meals participation was up 35% from September 2019 to September 2020. After COVID is hopefully done, they will reassess the Home Delivery Meal Program participants. Also, Daybreak staff continues to do Zoom calls to Daybreak clients.

Donald stated they did Dinning with Dignity and they use the money to buy meals for the vulnerable population, which includes seniors.

Donna stated she would like to combine both. Donna stated she talked to seven people from Sarah Deardorff's complex and they said they would like additional information. The persons who have volunteered are Larry, Donna, Rick, Deborah, and Danada. Abby stated she will be sending an email assigning volunteers.
