Please tell us about yourself and why you want to serve.

I have been a caregiver for 9 years: my parents lived with us for 8 years and both passed in 2021. After they passed, I am a full time caregiver for my husband. I became a licensed caregiver and have worked in residential homes and for private clients in order to better understand how to take care of my parents (in 2019). I have seen the devastation seniors face when they are handicapped, have medical needs that cannot be addressed, properly, due to lack of transportation or family member availability. It pains me when I hear a senior citizen tell me that their social security is going to their rent, and very little else. I would like to make a difference in brining about alternatives to caretaking for seniors. More community involvement through volunteering, student nurses (clinical), reaching out to non-profits who are willing to be trained and committed to assigning members to help seniors who need help in the home, financially (grants), companionship (at least 3 hours/day), med student clinicians (work into med school pre-regs) for home visits, and getting seniors the medication, which otherwise they cannot afford. There are many ways through community involvement, especially churches. It's just a matter of making others aware and going to them for support (I know, sounds easier said ...). However, I would like to put together a program where I would solicit and target nonprofits, initially, then work to get UNR on board to have their students rotate in a program provided by the county, as they receive credit for clinical requirements. In addition, I would request others in the committee to brainstorm ideas that would create SOP's for the above suggestions. It is possible and doable. I have first hand experience of what it is like for seniors who are healthy one day, then via stroke, broken hip, diabetes, etc., they are no longer able to care for themselves, and the only alternative is a SNF unit to reside until they pass. I am a huge advocate to better their lives.

I have had experience in management over the past 30 years. Owned my own business' for 20 years. I enjoy working with others to see an idea actualize. I have been (and now, currently, once again), a Director of Operations for a start-up medical device company. I have written SOP's for various medical marijuana establishments (2016-2108), as a compliance consultant, in the medical marijuana field. Main focus as a consultant was assisting in issuance of licensing, and maintaining compliance with the state (NAC's & NRS). Served on an HOA board for 5 years (2012-2017): 4 years secretary and 1 year as president.
