As a 41-year resident of Washoe County, and as a 79 year-old partially disabled senior, I believe that I am very knowledgeable in the needs of Seniors, especially disabled seniors, in our community. With my past career in all levels of government, including at the Federal and Nevada State levels, I believe that my experience in government can help bring new insights into services that Washoe County should provide.

I served three consecutive 2-year terms, 6 years total, on one of the Industry Specific Advisory Committees to the US Department of Commerce. This position requires approval from the US Secretary of Commerce. Because of this experience I was then selected to serve a 4-year term on the Intergovernmental Advisory Committee of the United States Trade Representative (USTR). My invitation to this committee came directly from the US Trade Representative himself. I also served 13 years on the Nevada Governor's Office of Economic Development (GOED), serving under three different Governors. The programs that I developed and implemented during this time created 35,000 new jobs in Nevada. I have also served on the Board of the Northern Nevada International Development Center, a part of UNR. I have also been serving on the Board of a private gold mining company in Nevada. My experience on Boards and Commissions, in both the Public and Private sectors, provides me insights that few other people have experienced.
