There are things that Washoe County does right, but there is a lot of room for improvement in offering help to seniors. I would love to be part of the team that would bring new, or updated, services to the seniors of Washoe County. My life has been spent in service to others, and this would be yet another way for me to help those without a voice.

As a law practice management consultant for more than 35 years, my experience is primarily in the legal community. I have served for 32 years on a committee that serves solo and small firm lawyers of the WA State Bar Association, served on a WSBA taskforce charged with rewriting some of the rules of professional ethics for WA attorneys, argued and persuaded the WA Bar to change several ethics rules and legal education requirements for attorneys, co-chaired an annual conference for WSBA for the past 20 years, served as a liaison between a professional association and the Law Practice Management Section of the CA State Bar Association for five years, been a featured speaker at over 100 continuing legal education programs for attorneys for state bar associations and the American Bar Association, spoken at NY Legal Tech Show twice, and had a book on how to manage a law practice published by the ABA. In each instance, I was an advocate for solo and small firm lawyers. In addition, I moved to Reno in 2012 to take care of my Dad up until his death in 2020. In 2016, my Mother, who was living in Arizona was diagnosed Alzheimer's and I became her long-distance care manager until her death in 2021. In 2017, I added my brother David to the house with my Dad. David is developmentally challenged and cannot live alone, so I am now is caregiver. He will be 74 in August. I am well attuned through my own set of circumstances, as well as those of my family members, to the challenges of aging and believe I would be a very useful addition to any group working on behalf of seniors.
