

Requests for Confidential Address

Qualifying Under NRS 250.140, NRS 247.540 and NRS 293.908

When to use this packet:

- You are a resident of Washoe County.
- You meet one of the statutory requirements listed above.
- You wish for your personal information to remain confidential.

Step 1 – Complete the following Documents:

- Affidavit for Personal Information to Remain Confidential.
 - Attach a copy of your Nevada Driver’s License and your work identification or credentials.
 - The Affidavit requires your signature to be notarized/verified. This may be done prior to your submission to the Court or you sign in front of a Court Clerk when you bring it in for submission.
 - For the Recorder Affidavit only, you must attach a copy of all document numbers containing personal information you wish to be kept confidential as an exhibit. *(Document numbers can be obtained by contacting the Washoe County Recorder’s Office.)*
- Order Granting Affidavit.
 - Add Affiant’s name to the caption.
 - Leave the date and Judge’s signature line blank. The Court will fill this out at the time the Order is granted.
 - For the Recorder Order only, you must attach a copy of all document numbers containing personal information you wish to be kept confidential as an exhibit. *(Document numbers can be obtained by contacting the Washoe County Recorder’s Office.)*

Step 2 – Submission of Affidavit and Order to the Court *(must be completed in person):*

Bring completed Affidavit and Order (without signature) to the Civil Counter at Sparks Justice Court located at 1675 E. Prater Way, Suite 107, Sparks, Nevada during regular business hours. You will be contacted by the Court when the Certified Copy of your Order is ready to be picked up.

Step 3 – Provide a Certified Copy of your Order to:

- Washoe County Assessor’s Office;
- Washoe County Recorder’s Office;
- Nevada Secretary of State, County Clerk, or City Clerk.

The penalty for willfully making a false statement under the penalty of perjury is a minimum of 1 year and a maximum of 4 years in prison. In addition, the Court may impose a fine of not more than \$5,000.

8 expose the person to comparable dangers.

9 I. _____ Any county manager in this State.

10 J. _____ Any inspector, officer or investigator employed by this State or a political
11 subdivision of this State designated by his or her employer as defined
12 under NRS 293.908(j).

13 K. _____ Any county or city clerk or registrar of voters charged with the powers
14 and duties relating to elections and any deputy appointed by the county or
15 city clerk or registrar of voters in the elections division of the county or
16 city.

17 L. _____ The spouse, domestic partner or minor child of a person described in
18 paragraphs (A) to (K), inclusive.

19 M. _____ The surviving spouse, domestic partner or minor child of a person
20 described in paragraphs (A) to (K), inclusive, who was killed in the
21 performance of his or her duties.

Good cause appearing, this Court believes it is fully informed of the premises and of the facts and circumstances of this matter.

Now, therefore, it is hereby ordered, adjudged, and decreed in accordance with NRS 293.906 et seq. that Petitioner’s personal information contained in the records of the Nevada Secretary of State, Washoe County Clerk, or the City of Sparks Clerk be kept confidential by the corresponding entity and Petitioner’s confidential information may only be disclosed as provided in NRS 239.0115 or 293.912.
