

800 MHz Joint Operating Committee Meeting: *NDOT Correspondence*

Nevada Shared Radio System (NSRS):

- Washoe County, NDOT & NV Energy have entered into a new NSRS agreement.
- Parties to the new NSRS agreement have agreed to upgrade the current EDACS radio system to a statewide P25 Phase II system.
- The transition to the new P25 system is expected to take 5-7 years.
- The new NSRS Agreement specifies that none of the parties to the agreement will pay for use of another party's respective portion of the system.
 - For example: NV Energy will not pay to use NDOT's radios sites.
- NDOT currently pays for their use on the Washoe County Regional Communication System (WCRCS).
- WCRCS agencies do not pay for their use of NDOT or NV Energy radio system infrastructure.

- NDOT intends to terminate their participation in the Washoe County Regional Communication System (WCRCS) Interlocal Agreement.
 - Effective date: when NDOT no longer requires services provided by the Current 800 MHz EDACS radio System.
 - Expected to be 5 7 years
 - Until Effective date, NDOT will continue to participate as a USER of WCRCS and will comply with the WCRCS Interlocal.
 - NDOT will continue to contribute to the WCRCS operations and infrastructure funds.
 - Upon Effective date, NDOT requests a waiver of WCRCS Interlocal section 19.3.
 - NDOT requests confirmation at the earliest convenience of the JOC and Washoe County Technology Services that the waiver will be granted.

Two budget scenarios

- 1. Business as Usual:
 - Current FY 18 Budget as a point of reference.
- NDOT withdrawal from WCRCS:
 - NSRS (NDOT & NV Energy) costs redistributed to other WCRCS agencies.
 - This is the outcome NDOT has requested.



WCRCS Agencies – Active Radios on NSRS Sites

WCRCS Agencies have more Active radios on NSRS (NDOT & NV Energy) sites (3,319) than NDOT has on WCRCS sites (1,513).


There are 9,319 active radios on the NSRS (NDOT & NV Energy sites) system.

Active Units on NSRS System not including WCRCS Sites




WCRCS Agencies make up 35% of active units on the NSRS.

Active Units on WCRCS not including NSRS sites




State agencies (NDOT, NHP) make up 25% of active units on the WCRCS.

WCRCS agencies make up 4.3% of talktime on NSRS IMCs.

State agencies (NDOT, NHP) make up 20% of talktime on the Washoe County IMC.

 - 1. Modify WCRCS Interlocal to terminate NDOT's participation and allow for waiver of section 19.3.
 - 2. Confirm future waiver of section 19.3 requirements for NDOT.
 - Washoe County Tech Services staff will prepare staff reports with recommendations for action.
