SUBJECT:

Funding request for network switching center modifications to support the P25 System, \$12,000. A review, discussion and possible action to approve the utilization of WCRCS professional services funds to contract with Collins Telecommunications, LLC to modify and prepare equipment in the WCRCS Network Switching Center for the pending installation of P25 System, not to exceed [\$12,000].

SUMMARY:

In preparation for installation of the P25 System core Network Switching Center equipment a number of modifications must be made at the Washoe County Regional Communications System (WCRCS) Network Operations Center (NOC). The modifications include:

- Clearing out old hardware and cabling in Washoe County IMC, located at Spectrum Blvd, to facilitate installation of second GMIM and GVIU Cards in Cabinet 1 Shelf 1.
- Removal of old/unused CIM, VMIM, and other concentrators and HDLC jumpers from all shelves in both cabinets, making sure to leave the GVIU concentrator items that may already be installed in Cabinet 1, Shelf 1.
- Cleanup and organize the cabling in both cabinets to allow for simple, unimpeded access during the GMIM installation.

This request is being made to the 800 MHz Joint Operating Committee because the work supports installation of the P25 System Network Switching Center at the Spectrum Blvd. location and is not specifically an Operations and Maintenance function of the 800 MHz system.

FISCAL IMPACT:

The fiscal year 2019-2020 WCRCS Adopted Budget has sufficient authority within the Washoe County Regional Communications System Fund (210) in the amount of [\$12,000] from C210010, GL 710100 (professional services). If approved, the amount invoiced would be transferred from the account above to the P25 System account from which the invoice would be paid.

RECOMMENDATION:

Approve utilization of WCRCS professional services funds to contract with Collins Telecommunications, LLC to modify and prepare equipment in the WCRCS Network Switching Center for the pending installation of P25 System, not to exceed [\$12,000].
