

Truckee Meadows Water Authority LID Reduction





- Region 1 Cut-Over activities
 - Sites from Tonopah to Clark County are converting to P25
 - Activity started July 8th
 - There will be a 30 day burn-in period
 - No changes on the system while burn in occurs
 - Voice Quality is Crisp and Clear
 - The expectations was a Robotic sound: but the voice quality appears to be an improvement from EDACS.



Nevada Shared Radio System Update for Region 2

- Incline Sheriff's Office & Biltmore
 - Permit approved by TRPA
 - RX3 Construction Completed
 - NVE Power addition to Incline Sheriff's and Communication H-frame Hook up for Site on Wheels
 - Biltmore Cabinet to be installed on Watertank APN
 - Foundation installed and Cabinet to be installed
 - Wave guide correction work to be completed during microwave installations
 - Microwave work to begin August 19th, 2024
- Red Peak
 - Lease agreement approved by BCC
 - Lease agreement effective in FY 25
 - Permitting expected to take 6 weeks.
 - AWAITING NOTICE TO PROCEED FOR CONSTRUCTION FROM OWNER



Nevada Shared Radio System Project Update: REGION 2

- Marble Bluff
 - Awaiting approval from Tribe to move forward with signing NVE Right of Way agreement.
 - 2 weeks remaining on construction work.
 - P25 Antenna installation to occur by September 2024
- RX3
 - Completed Biltmore
 - Load center connections to be made during the week of August 12th
- Microwave Deployment (Outages will stay on Wednesdays)
 - Snowflake ←→ Biltmore August 19 through August 23, 2024
 - Biltmore ←→ Slide August 26 through August 30th, 2024
- DELAYED TO SPRING 2025**
 - Marble ←→ Poito
 - Poito $\leftarrow \rightarrow$ Fox
 - Red Peak ←→ Spectrum
 - Red Peak ←→ Virginia



Nevada Shared Radio System Project Update: Project Pause



- Project Pause-
 - L3Harris is negotiating a program pause with the Nevada Shared Radio System (NSRS)
 - NSRS Members are unable to provide enough site to L3Harris for P25 Installation.
 - Details of Negotiation are **confidential** at this time.
 - Washoe County is not meeting scheduled timelines with site completions
 - BLM Permits : Smokey Quartz & Seven Lakes
 - Ashfields (stuck in JOC Committee for more than 18 months)
 - Red Peak (Owners has yet to send Notice to Proceed, and hasn't signed Lease agreement)
 - <u>Biltmore</u> (Completion of Cabinet installation and power expected by August for microwave deployment, no permanent solution created- awaiting schedule for EKN Astoria Waldorf Casino Build.)
 - Marble Bluff delays in Right Of Way agreement for NVE Power
 - Mt Rose delays in getting new ice bridge installed (site owner must approved design)
 - Poito awaiting site owner to move equipment to make room for Microwave and P25 equipment.
