5. APPOINTMENT OF P25 TECHNICAL ADVISORY COMMITTEE MEMBERS

Chair Ryan Sommers, North Lake Tahoe Fire Protection District, indicated there were two vacancies to fill, one for the at-large seat and one for a Washoe County representative. He asked whether Mr. Taylor would be interested in remaining on the Committee for another term. Mr. Taylor asked whether there would be any conflicts with him being on an advisory committee now that he provides contracting services, including providing advice to technical staff and assisting in updates and repairs. It was decided that the appointment of the at-large position would be continued to allow Deputy District Attorney Wade Carner to determine if there would be any conflicts with the appointment.

Regarding the Washoe County representative, Captain Joseph Colacurcio, Washoe County Sheriff's Office, confirmed that the Sheriff's Office was currently looking for a communications manager, and he was informed he would serve on this Committee, even potentially after the position is filled. No other nominations were made.

There was no response to the call for public comment.

Upon a call for the vote, Captain Joseph Colacurcio was appointed to the P25 Radio System Joint Operating Committee on an 8-0 vote.

6. NEVADA SHARED RADIO SYSTEM PROJECT

Adrian Arnold, Nevada Shared Radio System (NSRS) Administrator, stated that the program is implementing installation and commissioning at sites in regions 2 and 3 simultaneously with the goal of performing coverage and final system testing at the same time as well. Site implementations have been proceeding during the calendar year, he noted, and impacts due to vendor and material availability will likely compress the 2026 construction season.

Mr. Arnold spoke about negotiations taking place between all three NSRS members regarding L3 Harris's request for additional money. Each member is either considering or in negotiations with respect to their request, and it is possible that all three members could enter into a mediation process. There would not be any value in speculating until mediation occurs, and that is expected to happen at some point this winter. He remarked that parts of the project relied on federal workflow processes, and though there will be backlogs associated with that given the government shutdown, they should not pose long-term risks for the project. Permit acquisition for federal agencies, such as the Bureau of Land Management, which have real estate ownership of the sites could be impacted depending on the length of the shutdown.

The project is still anticipated to be completed in June of 2027, Mr. Arnold stated, and there would be fiscal impacts with the State allocation if the completion date moved beyond that point. The interconnectedness of all three NSRS members also effectively puts June 2027 as the risk date for the overall system to come online.

Tracy Moore indicated he was the new L3 account manager, and he is focused on providing customer and sales support in the State of Nevada. He hoped to be able to provide a sales order confirmation within 30 days of the request for a quote. He noted he is the representative for the whole state, so there could be small delays when he is traveling.
